Dear Mr. Weisberg, (Early February 1976)
Enclosed are clippings from the last few months. For the most part, the clippings deal with The King Assassination, which has been more in the news lately. I assume you saw TIME magazine (Jan. 26 ) which had an article which in essence said Ray was the lone assassin. I had it but somehow misplaced it end will try to get you a copy. If you have it let me knows. I feel bad about losing it, but if you have it I wont have to worry (although I'll try to get a copy any way). I also passed up an article in an obscure scandal sheet claiming JFK was Killed by a jealous husband. There was also an article by Shana Alexaridro in Good Housekeeping ar Ladies Home Journal on why the JFK assassination should be looked into again but there was nothing of substance just the usual "since watergate. and revelations about the CIA perhaps we should reopen i.. "etcetera, eteetera. What I do have in here is the OUI article on the different critics of the Warren Report, which portrays you in o flattering light for the most part. It was entertaining and I enjoyed the story about Mark Lone threatening to punch you. Also included, are several things from The VILLAGE VolE: One on the CBS assassination special on JFK, another d review of Robert Sam Anson's bock, concluding Oswald was guilty and another on the progress of Schweiker's committee. Is Schweiker's committee still at work? I a loo have a review from The New York $K$ Times' Book Review section' of Anson's book and Hugh McDonald's book. There is mare en McDonald in a couple of other articles from randal sheets. Also enclosed are o few interesting editorials from The New York Times. On the Crowdaddy article you'll note (Jan.1976) they lifted the blow op of the Altagens photo labeled "Lovelady or Oswald" right out of whitewash II. On the King assassination, I have a couple of articles by Dick Russell of the Voice enclosed, as well as a good number from The Now york Times and other Sources. I was in Cincinnati about a week before the arguments for the new trial were heard in the Sixth Circuit curt of Appeds. Had I been there I would have gone down to the courthouse but I had to be back here for my new semester of school.

A New Times article by Anson on JFK and the Mafias is included and I found it and its conclusions to be absurd. I also hove an EsaulRe article by Norse Ephron on Hugh Aynesworth and Bob Duaney of the Dallas Times Herald - they still believe Oswald to be the lone gunman. I should mention Argosy had a recent article by Allard Lowenstein on why the JFK and RFK murders should be reinvestigated. The article was a rehash and nut worth the dollar that the magazine was priced at, so I bidn't buy it. If I thought it hod anything you might want, I would have bought it.

One of the articles. I think you'll really
enjoy is the review of Anson's book by David Baling from NATIONAL REVIEW, One interesting point is that he (over)
criticizes every critic of the warren Report but you. Youll also note he refers to the back wound as a back wound not a neck wound. And as usual he criticizes the critics by using the warren Report as the gospel truth. Doesn't he realize its that Report that's in dispute. It's like defining a word and using the word in the definition. He tries to shoot down the critic's arguement by citing the Warren Report, which is what is being criticized.

There's also a number of other things. Recently PLAYBOY has been doing a series on Armenian assassinations Coming next month (April 1476) is the first of a two part article on the JFK assassination. I will send that in my next package.

passed. In that time, I got a hold of the Time Magazine (Jan.26) on the King murder. I have also ericlosed a new article by Anson in New Times on the Schweiker committee. I have also noticed Accessories AFTER THE FACTS is back in print with o forward by Schweiker. Peter Dole Scots has edited a book out row (the chapters include only reprints from other books and articles and since the chapter on the Milter tape from ERameup is included, you most be aware of it). The Scot book also has an article by Jim Lesar. What do you think of Peter Dale Scott?
