IS COOPERATION POSSIBLE ?

What a strange occurance this city has witnessed in the past few days. The Director of the Metropolitan Crime Commission has gone to jail for refusing to divulge his sources of information. There have been charges and counter-charges by both the District Attorney and the Metropolitan Crime Commission of undue interference on one hand and complete neglect on the other.

The strange thing is that both adversaries are constituted to achieve the same end, the detection and eradication of crime in our city. Although this does not imply a relationship devoid of friction, by its very nature, the Metropolitan Crime Commission is apt to rub official bodies as the Police Department and the District Attorney's office the wrong way, the present state of open warfare should not exist.

The Board of Directors of the YMBC feels that this state exists, not due to a lack of good faith on the part of either, but because of a lack of communication or perspective by one or the other or even both.

Therefore, the Board, in emergency session, has resolved to offer itself as a forum to mediate the present disagreement. It is the feeling of the Board that when men dedicated to a common goal meet in good faith, their differences can be reconciled. It is of particular value if a third party, equally dedicated but uninvolved, conduct this meeting.

ACTION, therefore, strongly recommends to Mr. Kohn and Mr. Garrison and their respective organizations that they avail themselves of the Y.M.B.C's offer.

It is a shame that so much effort is wasted when there is so much work to be done. There appears, in this issue, a paid advertisement entitled "A CHALLENGE TO DEBATE!" In this advertisement, Edward S. Butler, Executive Vice-President of the Information Council of the Americas, sets forth an opinion — that Lee Harvey Oswald was a Communist and killed President John F. Kennedy to advance revolution in America. This opinion is diametrically opposed to that of Mark Lane as expressed in his book and from the podium of the YMBC.

President Milton Fletchinger has invited both men to meet before the YMBC and debate the matter.

ACTION feels that such a debate would be not only interesting, but also productive and in the national interest.

It is perhaps necessary to enumerate the reasons why ACTION feels this debate would be both productive and in the national interest. First, as to being productive:

- 1.) The difference of opinion between the two men can be clearly stated. It is that Lee Harvey Oswald was a Communist, that he killed President Kennedy and that his motivation was to advance revolution in America.
- 2.) Both men are qualified to discuss the question: Mark Lane has dedicated the past four years to the subject, has authored a best-selling book on the subject and has worked, consulted, or discussed with numerous other analysts.

Ed Butler has been actively engaged in a crusade against Communism since 1961. His role in the crusade has been as a specialist in propaganda techniques. He has, in this role, testified before committees of both Houses of Congress. Furthermore, he has not only studied Oswald from his writings and recorded activities, but met and debated him. His recognized competence in this field certainly qualifies him to assess Oswald's political philosophy and motivation as well as anyone.

3.) The answer to the question of who is qualified to discuss whether or not Oswald pulled the trigger seems to hinge on the availability or access to evidence. The veracity of anyone's information may certainly be examined in debate.

That the resolution of such a question be attempted in a productive manner would be in the national interest is to AC-TION self-evident.

ACTION, therefore, urges both parties to accept Mr. Fletchinger's invitation to debate and respectfully suggests the subject should be:

"Resolved: That Lee Harvey Oswald was a Communist and killed President Kennedy to further revolution in America.
