I appreciate your letter very much. Thanks.

As you may have gathered, I do not regard most of the books as truly informative and too many misinform. Too many are thin theories. If you can find copies, I have the highest opiniin of Howard Roffman's Presumed Guilty and Sylvia Meagher's Accessories After the Fact. Forgive My Grief consists of reprinting comments Penn Jones published in his small Texas weekly before he sold it and, all in all, is prtty wild and not dependable.

The comprehensive bibliography to which you prefer is by Wrone and Guth, published by Greenwood Press, whose address is not at hand. It cost about \$50. You can reach Dave Wrone at 1518 Blackberry Lane, Stevens Point, Sisc. 54481. He may be able to provis a copy and get it replaced. Or, he can refer you.

As it finally appeared the book was titled Ogwald In New Orleans, with the subtitle Gase for Conspiracy With the CIA. Canyon Books did it and it has been out of print for years. They did it on the cheap because their normal distribution was denied them for that subject. I did not publish it but recently, and at high cost, I was able to obtain a few copies we make available, as long as they last, to those of geniuine interest. Ordinarily we do not let it be known that we have these few copies. The 95¢bbook is \$25.00.

I've lost track of the distribution of the Whitewash series. Far and away, the first did best. I think I had, before the xerox edition and including Dell's, more than 10 printings. I've never been able to get a straight accounting from Dell on the first two, which it did reprint. I've not just exhausted the first print of 10,000 on the second book, had to prove reprint the third, and still have a few of the 4th. The last two each print was of at least 5,000 copies.

Now that I am aging and unwell, I do appreciate lettre like yours, and I do thank you for it.

I would first of all like to express my appreciation to you for sending the WHITEWASH series so promptly. Having received them, I have read WHITEWASH, WHITEWASH II, and PHOTOGRAPHIC WHITEWASH. I am just starting WHITEWASH IV, and after that I will tackle POST-MORTEM. The first three are excellent. Need I say more? Superb. They are the most thoroughly researched books on the Kennedy case, I am convinced. It is a good thing that we have people like you in society who are willing to give of their time, money, and energy to make the truth about this most important investigation public to all of us.

Soon after I first became interested in the assassination of John F. Kennedy and its phoney "investigation", I became aware that it is the subject of many many books written.
