Among the illnesses I'm surviving is sleep apnea. It gets me up at night and often and because I'm so wide awake so early in order to get enough sleep I retire at about 7. Early but when I'm up in a few hours, necessary.

Some of your questions cannot be answered unequivocally.

One seems to presume what has no support in any evidence, that Ruby acted on the behalf of others: The Role of Jack Ruby.

There also is no evidence that Oswald was a government agent.

And there is nothing I can tell you about the shooting of J .D.Tippit that is not in my books.


The same is true of Oswald's innocence.
