Dear Mr. Weisberg,

My name is Jonathan Cohen. I am a 16 year old high school junior, and I've been greatly involved in study of the J.F.K. assassination for the past year and a half. I have attended three major symposiums on the assassination, and hope to attend the 30th anniversary conference in Dallas next November.

I am writing at the suggestion of my good friend Mary Ferrell. Mr. Weisberg, I have come to realize that you have been troubled by Mr. Harrison Livingstone. Anyone who attended the 1992 A.S.K. Symposium in Dallas can verify that Livingstone's rude and overbearing behavior were plainly obvious. Indeed, Livingstone was so miffed at not being invited to speak on a panel that he passed out a letter trying to form his own organization! That letter is enclosed. I want to re-assure you that you don't have to worry about Mr. Livingstone. Mr. Weisberg, I want to tell you - you have more friends out there than you could possibly imagine!

Secondly, I want to thank you for the enormous contributions you have made to the study of John F. Kennedy's death. Without your books, of which I have read all, or your constant suits through the Freedom of Information Act, the progress made in this case would be pushed back fifteen years. By your excellent research, you have paved the way for the second, and now, the third generation of researchers to press for an all-out release of government files on the case and, to come as close as is possible to solving this 30 year enigma. It is with this letter that I express, on behalf of the entire J.F.K. research community, my gratitude for your un-ending pursuit of truth in this case.

A Steering Committee was established last night, Oct 23, 1992, to help set up future meetings and conventions, and to assist and guide future research, and to prepare for the release of documents.

The next annual meeting will be this time next year in Washington, D.C., where our voices can be heard. There will be no further reporting from Dallas.

We will endeavor to have cheaper and more frequent meetings - semi-annual and quarterly, and regular regional meetings. In view of the massive amount of hoaxes, misrepresentation and fraud in our field, we will attempt to control and discipline such behavior, as do all professional organizations. Meetings will no longer be conducted along authoritarian lines or by commercial corporations feeding on us. We'll meet in laboratories if necessary. I've said it, folks.

Many prominent researchers are boycotting this A.S.R. meeting. The sponsors are not being paid by South by Southwest Corp. Press credentials have been denied to John Judge, Bill Kelly and numerous others. I have been criminally assaulted by the managers, and repeatedly threatened with arrest. For two years I have been unable to speak or take questions on my findings. Jim Hoar will not come here and many are offended.
