

Dear Dharon Carta- Oswald in New Orleans is out of Print. All four parts of Post Mortem are now out, too late for the current Books In Print. You also don't have Whitewash IV. Flyer enclosed. To the degree I can I address the Kennedy family and its situation in the Epilogue to Whitewash II and several places in Post Mortem, esp. chapter "Hades Not Camelot." There is little they can do except trust the fools that they have always trusted. ...One can conjecture limitlessly about who may have been behind the assassinations but solid proofs are lacking and there is none of tangible connection between the assassinations. ...By the time I can return to writing I would surely love a proof- and copyreading but Connecticut is 300 or more miles away. However, I'll file your kind offer. I do much regret having no choice and printing rough drafts. I'm into that much too much. ...Sorry can't answer further. Dear Mr. Weisberg,

I have read your books Whitewash, Whitewash II, Photographic Whitewash and Frame-Up and am interested to know if I can order any of your other books from you. On the page with the copyright on it in Frame-Up, Oswald in New Orleans: Case for Conspiracy with the CIA, Post Mortem: Suppressed Kennedy Autopsy & Post Mortem II: Secrets of the Kennedy Autopsy are listed as other books you have written. However, my sister, who works in a bookstore, looked up those books for me, because I wanted to order them, and they are not listed in Books in Print. Have these been published? If so, would you please send me the prices of each so that I can order them? Thank you.

Also, there is a question I would like to ask you. I've read an average amount about the Kennedy assassination (your books I listed, Rush to Judgment, "They've Killed the President" and various magazine articles) and this question has always come to my mind when I've been reading each book. Where are the Kennedys? Why aren't

they clamoring for a new investigation? Two reasons for their silence seem to present themselves: 1) that they don't want to live through the trauma and the publicity again - this seems like a poor excuse for not wishing to know the truth. Although it would be extremely painful, I would think that finally knowing the truth would be worth it. (I discount the idea that they really believe the Warren Commission Report - they couldn't be that naïve) and 2) that they are afraid to speak up because they are fearful that Ed Kennedy may be killed also (if they believe this then it's obvious that they believe in a conspiracy and that the conspirators are still alive and have sufficient power to strike again (for example if the CIA, FBI or Mafia were involved as I believe they were). Or they could be being blackmailed by the conspirators or the above agencies to keep quiet. What are your ideas on this subject? You don't seem to have touched on this subject in the books I have read. Also, is there any proof of conjunction of John & Robert's assassinations? That is, did the same conspirators do both?
