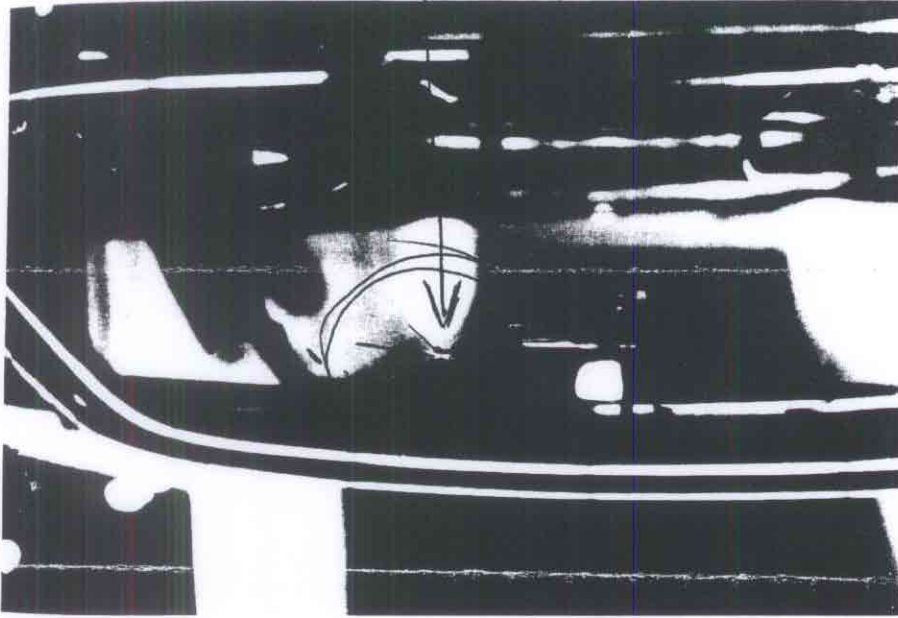

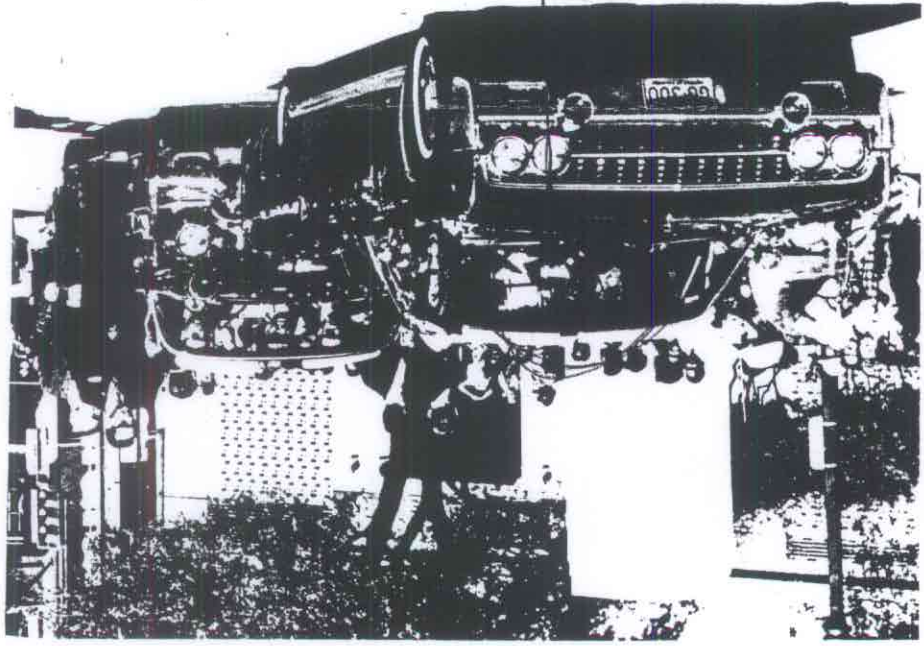

COMMISSION EXHIBIT NO. 350: Cracked windshield of presidential limousine.



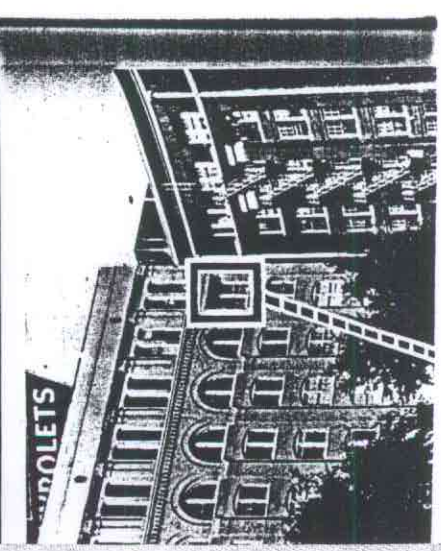
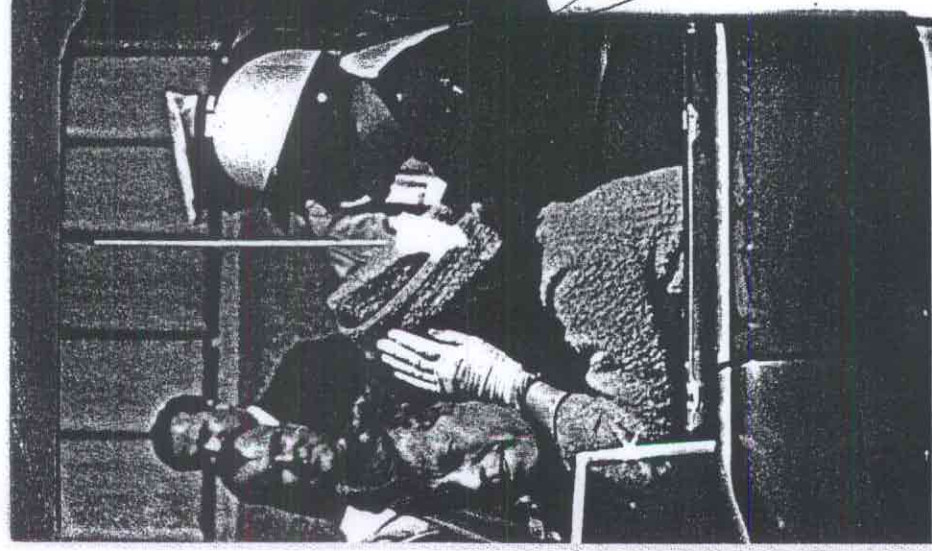
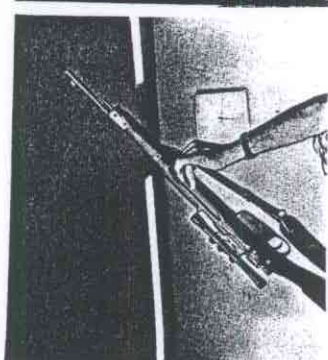
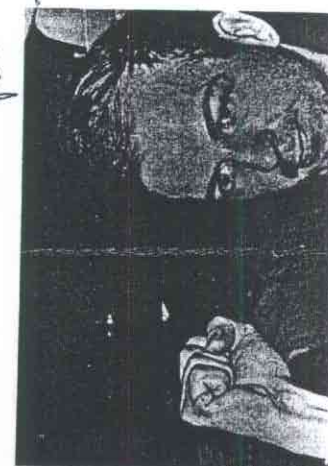
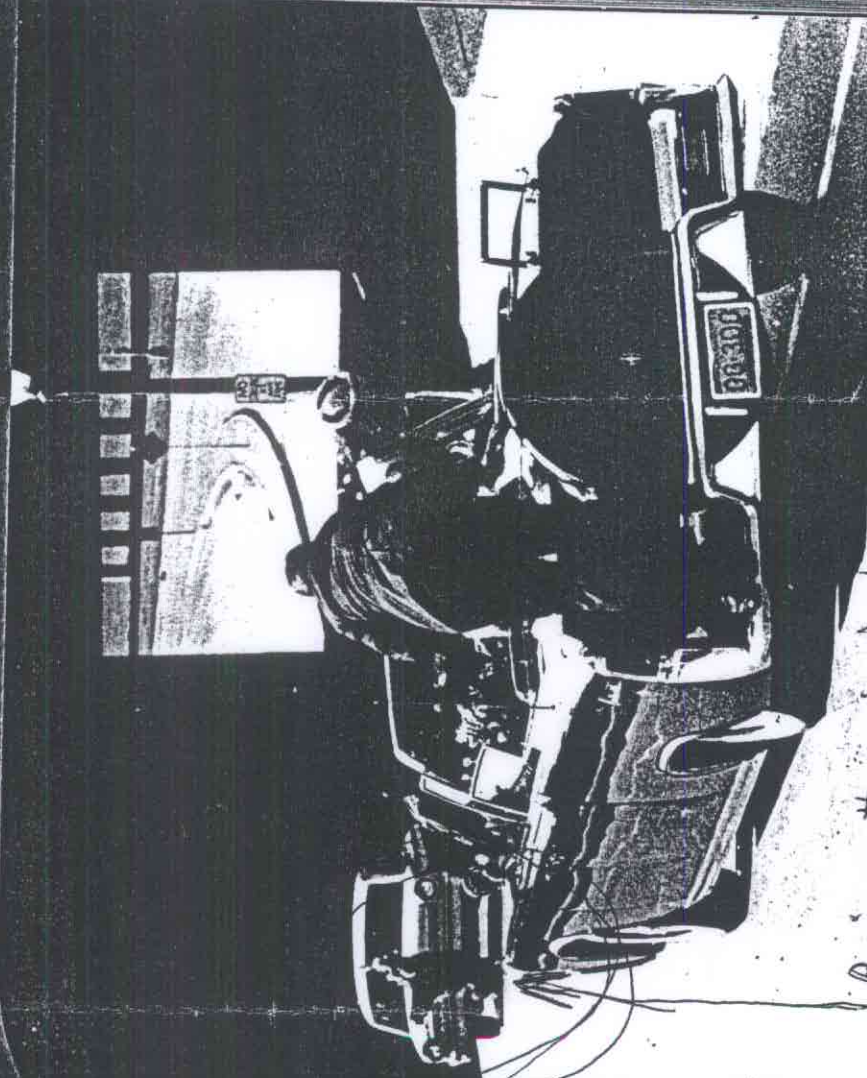
COMMISSION EXHIBIT NO. 900: Photo by AP photographer James W. Aligens showing President Kennedy reacting to the first of the two shots which hit him.
