Dear Mr. Weisberg,

As one of the original ones who never accepted the contents of the Earl Warren Jokebook, I have read your delineations with great interest, along with those of Lane, Jones, Garrison, Manchester, Eishop, etc.

As an assassination buff I have mulled over the multitudinous facets of this possibly-soon-to-be-exposed conspiracy, and I may have stumbled upon something.

Scenario I Oswald was hired by H.L. Hunt, or the hoodlums dispossessed from their lush pickings in Havana, or whoever, for the ostensible purpose of shooting Kennedy, either to wound or to kill. As has been established, there were two or more Oswald look-alikes doing their thing, at the gun range, shopping for a car, etc. Their existence was not known to Oswald. Further unknown to him, his 1st shot was to be the signal for the other killers to open fire. There had to have been at least one more rifleman, possibly 3. They were to complete what Oswald unwittingly set in mind motion. (He did state, "I'm just a patsy"). The original plan called for Oswald to leave the rifle deliberately, where it would be found. Their ownly logical choice was to murder him....he was a strong-willed man so they couldn't browbeat him, and you can't bribe a millionaire --- ergo, you have no other choice, given the situation.

But to return to Dallas. As I believe both Lane and Garrison established, at the time of the killing a light plane was observed idling at a nearby airfield, with two men around it, as the waiting for a passenger. One of these men was probably Ferrie, who was subsequently silenced forever the same way several dozen other people have been. Oswald was possibly previously introduced to Ferrie, or whover, and told that he would be flown away safely following the killing/wounding. The higher-ups then pulled a double-cross, and ordered Tippet to kill Oswald while ostensibly apprehending him in accordance with the police broadcast. Oswald may have caught wise in a flash, made an instant decision and Killed Tippet instead. (To further confuse the issue, perhaps an Oswald-double did the job,

As I presumm you know, said cases had been worked thru the mechanism of a rifle several times, as shown by FBI lab tests, which were probably accurate and impartial since at that time the lab technicians didn't know what they were supposed to ascertain or not ascertain. Commander Hume and the others at the autopsy were, of course "reached" and told what to say.

A possibility of the firing order at the killing: Killer #1, anticipating Oswald's shot, (or fearful that it might never come) opened up from the knoll with the original throat shot, then Oswald hit Connally, either by accident or design, then Killer #2 gave the head shot that slammed Kennedy backwards and definitely killed him: this 3rd shot also came from the knoll, either from a 2nd gunman. or a reload by #1. If he was using an automatic rifle, the time factor is a negated. And both #1 and #2 would logically use the finest weapons available; they need only be of a similar caliber (.30) to that of the piece of schlock with which they set up Oswald. If they did their jobs reasonably well, there would be no signifigant pieces recoverable for a ballistics analysis.

I submit the above thats for whatever they're worth.
