I also told you that in connection with a book I've researched and begun to write some of my subsequent work I as not willing to give eway. This relates to training camps and my other New Orleans work.

In the broader super of your project I have done much work. I researched that book years age and had to lay it anide. I hope to return to it so while I am willing to be of what help I may in what can be a worthwhile project you understand that I cannot give this work away minute either.

Because from your description this does appear to be a worthwhile project I did offer to spend a limited amount of time without compensation. This is because I cannot keep up with my own work and because I am used as a paid consultant by other elements of the media.

I explained that if we have any mostings I would want them taped and after GES' use of the tapes was part they would be returned to so for whatever value they may have in an oral-history project in which a university system is interested and on which I have not been able to perform. Because this is an official report of a supposed investigation to which previously searet repords were available this also illustrates what I conceive to be part of the many problems you face. Despite his investigator powers and authorities he was conned by the spooks. One example of this is his making of names where there was no need to mask them. I have files on all of them. This is one way of saying that I have an avarances of your problems and the amount of time that can be wasted in attempting to resolve them.
