in 2.2 seconds)

- no time; jammed at third cartridge

5.2 seconds - 1 hit, two low

5.0 seconds - 1 hit, 2 upper left

2. Ron George, Maryland State Trooper

- no time; jammed after 2nd shot; 3rd
fired very late

- no time; 3rd bullet jammed

4.9 seconds - 2 hits, 1 upper right

3. John Concini, Maryland State Trooper

- 6.1 seconds - not sure of hits

5.4 seconds - 1 hit, 2 just low

4. Howard Donahue, weapons engineer

- no time - second bullet jammed
(bolt too quick)

- no time - jam after 1st shot
(again too quick)

5.2 seconds - 3 hits grouped in head
area (BEST THREE)

5. Mr. Fitchett, sporting goods dealer

6.5 seconds - 3 borderline hits, low & left

6.0 seconds - 1 hit, 2 low

5.1 seconds - not sure of hits

6. Somerset Fitchett, sportsman

- no time - jammed at 3rd bullet

5.9 seconds - 2 hits, 1 wide left

5.5 seconds - 2 hits, one low

7. John Bollendorf, ballistics technician

6.8 seconds - 2 hits, 1 low left

- no time - jam after 2nd shot

- no time - jam again

6.5 seconds - 1 hit, 2 near misses upper left

sound: Larry Mizrahi

8. Douglas Beaumore, ex-paratrooper

(wounded in Vietnam)

- no time, unused to bolt action; too stiff

- no time, unable to work bolt fast enough

- no time, simply too stiff for him

- no time, 2 shots in 5 seconds; 3 in 9

9. Pat Olson, R.P. White employee

- no time, jammed after 1 shot

- no time, jammed

5.4 seconds - tight group high
right in blue

10. Sid Price, R.P. White employee
5.9 seconds - 1 hit, 1 blue, 1 nowhere
4.3 seconds - not sure if any hits
- no time, jam after 2nd shot
4.1 seconds - 1 hit, 2 complete misses
(off blue) (FASTER TIME)

11. Charles Hardy, R.P. White employee

- no time, jammed

- no time, jammed

6.5 seconds - 2 near misses, 1 nowhere

SUMMARY:

These riflemen used various techniques; some took the rifle off their shoulder more than others. No one liked the scope.

Out of 37 attempts to fire 3 shots at the moving target, only 20 record times were taken. In the other 17 cases, either a bullet jammed in the bolt-cycling process, for no time whatsoever, or the balky bolt slowed him up so much that the target completed its run before the rifleman would get off his third shot.

The average time, out of 20 recorded attempts, was 5.6 seconds.

Fastest was 4.1; slowest, 6.6. Times are approximate; we can get them down to hundredths of a second if desired when applying superimposed timer.

Dear Mr. Schaffler,

I wish to acknowledge the receipt of your letter of 13 July 1967 in which you express regret that it will not be possible to provide me with the detailed results of the CBS marksmanship and wound penetration statistics tests which I requested in a letter of June 19th addressed to Leslie Hidley. I was certain that CBS would not be willing to give the information I requested, irrelevant of any "long standing policy prohibiting the release of any research material..." because the detailed results of the CBS tests would further betray the mendacious and propagandistic nature of the infamous "news inquiry."

I believe that a super-organization like CBS and its servants are answerable to power, exercised cynically and treacherously, without the slightest inhibition of conscience or integrity. CBS is utterly indifferent to the salvation of the few individuals who have authoritative knowledge of the Warren Report's chicanery, to its transparent propaganda ploy—the "news inquiry" was addressed to a mass audience ill-equipped to resist or understand the manipulation of facts by opinion-makers like CBS.

In your "long standing policy" notwithstanding, I have obtained the detailed results of the CBS marksmanship tests. I know the precise scores achieved by DeLoach, George, Concini, Zanahan, Fitchett, Tomanoff, Farber, Gandy, and Hamby. I know the average of hits per series of three. And I know how many times the replica rifle jammed.

As deeply as I loath—and bitterly as I hate the still-unidentified assassins who slaughtered the President on the streets of Dallas, my contempt for those who claim to be the truth like CBS is even greater. Critics of the Warren Report, contented to exposing its fallacy and deceitfulness, have little sympathy to spare for the auxiliary villainies of the news media; and I intend to do the same now time on protests to the architects of the CBS travesty of justice and their lackeys. So far as I am concerned, you may keep your "news inquiry" secret forever, while you sanctimoniously shield or defend—without budging the Jaquard film and suppressing the autopsy photographs of the organs—the proof of your duplicity and charlatanism is already

Dear Mr. Midgley,

I refer to the CBS News Inquiry on the Warren Report, which I watched with very great interest. Would it be possible to provide me with:

- (1) The complete record of the scores achieved by the eleven volunteers who participated in the CBS marksmanship tests.
- (2) The rating as a rifleman of each of the eleven volunteers.
- (3) The complete record of the wound penetration ballistics tests performed by Dr. Olivier for CBS, indicating the number of trials and the distance travelled by each test bullet.
- (4) The number of test bullets that penetrated the plywood in the simulated wrist gelatin, in relation to the total bullets fired.
- (5) Photographs or detailed descriptions of the recovered test bullets, including those which lodged in the simulated wrist gelatin.

This information would be of great value in connection with a review of the CBS News Inquiry which I have been requested to write for magazine publication, and also for possible mention in my book on the Warren Report which is in process of publication for release in the fall by Bobbs-Merrill Inc.
