DEAR MR VICE PRESIDENT:

AS THE OFFICIAL INVESTIGATOR FOR SEVERAL FAMILIES OF THE DECEASED MEMBERS OF THE SYMBIONESE LIBERATION ARMY, KILLED AND BURNED IN LOS ANGELES CALIFORNIA MAY 17, 1974, BY THE LOS ANGELES POLICE DEPARTMENT AND OTHERS, I WISH TO PLACE BEFORE YOUR COMMITTEE CERTAIN PERTINENT EVIDENCE INCLUDING TAPE RECORDINGS AND DOCUMENTS CONCERNING TERRORIST ACTIVITIES AND THEIR COVER-UP.

1. THE FOUNDING AND FUNDING OF THE TERRORISTS ORGANIZATION BY ELEMENTS ASSOCIATED WITH AND CLOSE TO THE CENTRAL INTELLIGENCE AGENCY (CIA).
2. THE INVOLVEMENT OF INTELLIGENCE AGENCIES WITH SEVERAL MEMBERS OF THE SYMBIONESE LIBERATION ARMY (SLA).
3. THE KNOWLEDGE BY INTELLIGENCE AGENCIES OF THE PRE-PLANNED EXTERMINATION OF MEMBERS OF THE SYMBIONESE LIBERATION ARMY ON MAY 17, 1974.
