This afternoon Mr. W. J. Liebeler of the President's Commission telephoned.

Mr. Liebeler stated that in connection with the arrest of Cswald on August 9, 1963, by the New Orleans Police Department it was ascertained that Oswald had in his possession a pamphlet entitled "The Crime Against Cuba" written by Corliss LaMont. On the pamphlet by rubber stamp was the following, "FPCC, 544 Camp Street, New Orleans, La."

Mr. Liebeler stated that Secret Service had conducted extensive investigation to ascertain relationship to and association by Oswald with the Camp Street address and had developed no pertinent information. According to Liebeler, the Secret Service had checked with the New Orleans FBI Office and had been advised that the FBI in New Orleans had also checked on Oswald's relationship to the Camp Street address with negative results.

Mr. Liebeler stated that he had the two following requests:

- l. He would like to be furnished with copies of any FBI reports setting forth the investigation conducted by the FBI regarding Oswald's association with the Camp Street address. (Liebeler stated such reports may have been furnished to the Commission but his file room could not locate any.)
- 2. Mr. Liebeler would like to have furnished the original pamphlet which Oswald had in his possession at the time of his arrest on 8/9/63. Mr. Liebeler identified their Secret Service report of the investigation of this matter as Secret Service Control Number 517, report dated 12/9/63, at New Orleins, by Agent Gerrets.

ACTION:

Supervisor Lenihan of the Domestic Intelligence Division was advised of Mr. Liebeler's request and after checking advised the Bureau investigation of Oswald's association with the Camp Street address was covered on Pages 680-683 of Dallas report 12/2/63 in the Oswald case which report was by SA Warren C. DeBrueys. This same report on Page 371 sets forth that Lieutenant Martello of the New Orleans Police Department turned over all material including the original pamphlet taken from Oswald at the time of his arrest to Agent Adrian G. Vial of Secret Service.

This information was furnished to Mr. Liebeler who stated he would locate the above-mentioned report and as to the original document he would contact Secret Service to obtain it and no further action needed to be taken by the Bureau.
