## WILD SOUND, MUSCI

PETER DALE SCOTT, A CANADIAN, ONCE A DIPLOMAT NOW A PROFESSOR AT THE UNIVERSITY OF CALIFORNIA. IN SEPTEMBER THE COMMITTEE OF THE UNITED STATES CONGRESS STUDYING THE ASSASSINATION FLEW HIM TO WASHINGTON TO COUNSEL THEIR INVESTIGATION. HE HAS GAINED AN INTERNATIONAL REPUTATION AS ONE OF THE MOST RIGOUROUS ANALYSTS OF THE EVENTS SUPROUNDING THE DEATH OF JCHN KENNEDY.

This wasn't a street crime to be solved by the Dallas police. This was a political arime with political consequences. Even in the sphere of foreign politics where we've been told that there was no shift of policy between Kennedy and Johnson. In some areas that just wasn't true. President Kennedy in the last 6 months of "63 was moving towards detente both in Guba in Vietnam and in both areas his peace initiatives were frustrated by his assassingtion. In the case of Vietnam he had accounced publicly on Nomvember 20, 1963 just two days before his death that there would be a with drawal of US troops from Vietnam. A thousand troops as the first stage of a major withdrawal and I was horrified to learn that 2 days after his death on November 24th this first step towards disengagement in Vietnam was secretely cancelled by the new Johnson administration.

THE BUILDINGS OF DEALY PLAZA. THE REASONS FOR THE MIRDER OF JOHN KENNEDY GO BOYOND THE SIXTH FLOOR OF THE BOOK DEPOSITORY BUILDING. NOVEMBER 22, 1963, AIR FORCE ONE BRINGS THE PRESIDENT OF THE UNITED STATES TO TEXAS IN AN ATTEMPT TO HEAL A FESTERING DIVISION. A SALOON BREWL BETWEEN THE CONSERVATIVE AND LIBERAL WINGS OF THE DEMOCRATIC PARTY. BUT CONSERVATIVE TEXANS WERE PERHAPS THE IMAST OF HIS ENEMIES IN THAT CONTENTIOUS YEAR. SOME SAY THAT KERNEDY HAD AS MANY BLOOD ENEMIES AS JACKEE HAD ROSES. HIS BROTHER BOBBY HAD DECLARED WAR ON THE MAFTA AND THE TEAMBTERS. A VENDETTA WAS REPUTEDLY SWORN OUT IN RETURN.

THERE WERE OTHERS AS POWERFUL. WATCHING IT UNFOLD FROM THE INSIDE WAS THE PENTAGON'S LIAISON OFFICER WITH THE CIA, COLONEL FLETCHER PROUTY:

There were all kinds of pressures. If you analyse that year' 1963 you can see that there ware major forces in combat with each o other at that period. There was a lot of power that differed with the policies of President Kennedy. Kennedy had told several people that after I get re-elected, I'M going to John F. Kennedy: tear the CIA into a thousand bits/

I've decided in the last 24 hours to discuss briefly at this time recent events in Cuba.

AFTER TAKING FOWER CASTRO EXPROPRIATED AMERICAN BUSINESS AND CLOSED THE MAFIA'S CASINOS. THESE PEOPLE WARTED CASTRO CUT.<sup>1</sup> AND DISASTROUS INVASION OF THE BAY OF PIGS WAS FOLLOWED BY THE MISSILE CRISIS, AND THERE WERE NEW WAR CRIES TO INVADE CUEA.

> KENNEDY REFUSED TO INVADE CUEA. IN FACT IN THE FALL OF 1953 HE ORDERED SECRET NEGOTIATIONS TO BEGIN WITH CASTRO. THE TALKS AIMED AT DETENTE WERE REGUN BY KENNEDY'S PERSONAL REPRESENTATIVE, DIPLOMAT WILLIAM ATWOOD.

That was the week before the president went to Dallas and so I was to see him right after the Dallas trip, of course, as we know, he never came back from Dallas.

MAIN STREET 12:25 P.M. SHORTLY BEFORE THE ESSASSINATION A MIAMI RIGHT WINGER HAD BEEN TAFED BY A POLICE INFORMANT. THE MAN DESCRIBED HOW KENNEDY WOULD BE MURBERED BY A HIGH POWERED RIFLE FROM THE WINDOW OF THE BUILDING. THREE MINUTES BEFORE THE ASSASSINATION THE MAIN POLICE RADIO CHANNEL IS MYSTERIOU SLY JAMMED.

Something is wrong here. Something is terribly wrrong. There's numerous people running up the hill along by Elm street there by the Stemmons Freeway. Several police officer are rushing up the hill at this time. From the hospital. There has been a shooting. Parkland Hospital has been advised to stand by for a servere gunshot wound. I repeat: a shooting in the motorcase in the downtown area. I can see many many motorcycles coming by now, police motorcycles, the presidential car coming up now. We know it's the Presidential car. We can see Mrs. Kennedy's face there. There's a secret service man spread eagle over the top of the car. The official body as I can see it.....toward the emergency room of Parkland Hospital. The policeman says: no you cannot come in here. You cannot come in here. We'll let mohody

alse in. It was definitely the President's car and just now we've received reports here at Parkland Hospital that Governor Connolly was shot in the upper left chost and the first unconfirmed reports say the President was hit in the head.

Just a moment, just a moment. We have a bulletin coming iu. I'll switch you directly to Parkland's Hospital.

The President of the United States is dead. President Kennedy has been assassinated. It's official now. The President is dead.

WILD SOUND, CHILDREN

THE DALLAS POLICE ASTONISHED THE WORLD. WITHIN 90 MINUTES OF THE CRIME THEY FIND THE RIFLE, A RUSTY THREE DOLLAR MODEL AND THREE SPENT BULLETS. AT A DALLAS MOVIE THEATRE THEY FIND THEIR MAN. There's a shot. Ocwald has been shot! Cswald has been shot! CHIEF JUSTICE EARL WARREN WAS COMMANDED TO SET MP A COMMISSION TO INVESTIGATE THE CRIME. FORMER PRESIDENT GERALD FORD WAS THE COMMISSIONER.

WHAT IS YOUR FEELING AS A MEMBER OF THE WARREN COMMISSION?

I think the Warren Commission did a vory therough job in investigating the assassination of President Kennedy and I firmly believe todays as I did then and it was a unanimous decision, that our basic concludions were right. Number one that Lee Harvey Oswald ub committed the assassination and number 2, the commission found no evidence of conspiracy, foreign or domestic.

DEALEY PLAZA. THE PRESIDENT'S CAR MOVED SLOWLY ALONG THE TOP LEFT OF THIS PICTURE, THEN MADE A HAIRPIN TURN TO ITS LEFT BRINING IT IN FRONT OF THE BOOK DEPOSITORY. 32 EYEWITNESSES SAID RIFLE FIRE CAME FROM BEHIND THE CAR BUT A TOTAL OF 64 SAID THE SOTS CAME FROM THE GRASSY KNOLL TO THE LOWER LEFT, INDICATING A SHOT FROM OTHER THAN A SNIFER'S NEXT ABOVE AND BEHIND KENNEDY. WILLIAM RENAMINI SAM THE PRESIDENT'S HEAD BLOWN BACKWARD.

Newman:

We heard the first shot and the President - I don't know who was

hit first. but the President jumped up on his feet. I'll bet it scared him. He thought it was a firecracker cause he looked you know here. And then as the car got directly in front of us well the gunshot, apparently from behind us, hit the President in the side, the side of the temple.

Reporter: Did you think the first gunshot came from behind you too?

Neuman: I think it came from the same location. Uh apparently back up on the uh knoll.

> DOCTORS AND PRESS SECRETARY, MALCOUM KILDUFF LEFT NO DOUBT WHERE THEY THOUGHT THE BULLET HAS COME FROM. JOSIAH TOMPSON (AUTHOR OF "SIX SECONDS IN DALLAS")

There's not a single witness in Dealey Plaza who said that the assassination as the Warren Commission believed it happened. Not a single witness saw both men hit by the same shot. Governor Connolly, who was hit, denies to this day that he was hit by the same shot that hit Kennedy.

John Connolly: Uh I had time to turn. Uh to try to see what had happened. I was in the process of turning again. But why, I felt the impact of a bullet.

Josiah Thompson: Uh now as you notice the uh limousine is behing the Stemmons freeway sign on that.....

THE WARREN COMMISSION REPORT HINGEST ON A SINGLE BULLET THEORY. IF KENNEDY AND CONNOLLY WERE NOT HIT BY THE SAME BULLET THERE HAD TO HAVE BEEN MORE THAN ONE RIFLEMAN.

.....Upraised, elbows splayed upward. Now here we're stopping at Zapruder frame 230. In this frame we can see the President obviously reacting to a bullet hit. Lock closely at Governor Connolly sitting directly in front of the President. You notice how composed he looked. Uh notice too that ha's holding his hat in his right hand. According to the Warren Commission that wrist has already been shattered by a bullet. When Connolly looked at this frame for us at Life Magazine he said it was quite clear to him that he'd not meen hit at this point and I think that's obviously the case. Now we're moving ahead. It is the immediate impact effects of a bulli hit. I asked Dr. Gregrory his surgeon at one point why his cheeks would puff and Gregory explained that the impact of the bullit penetrating the chest would have driven air upward through the um throught the trap door in the throat which would involutnarily open and it would puff the cheeks. All these are consistent than the bullit hit at this point. Seems to me that we've seen here then is the photographic disprocf of the single bullit theory. Now moving ahead in the film we're now nearing the point where President Kennedy is killed. There it is. Frame 313. Notice the enormous backward leftward snap of his head.

According to the Warren Commission he was shot directly from the rear. These impact effects, this movement is completely inconsistant with that uh direction of a firing point. It is consistent with a shot from the right front.

FORENSIC PATHOLOGIST CYRIL WECHF TALKED TO PETER DALE SCOTT.

399 - The hero of the Warren Consission report, the bullit which broke both a rib and the radius in John Connelly is in pristine condition except for minimal deformity at the base, is virginal in its condition. These two bullets were fired into cotton wadding, striking nothing coming to rest. This bullet, same ermanition, it looks like a wider piece of examplifion but it's the same, went through the carcass of a goat, striking one rib in the goat's chest. Notice its deformity. Look at its base. Look at its flattening due to the impact. This bullet went through the wrist of a human cadaver, breaking the distal end of the radius in the same fashion that that bone was broken (Governor John Connolly.) FORENSIC PATHOLOGIST CYRIL WECHT:

The single bullet theory says that one bullet struck the President in the back, coursed through his upper chest, exited from the front of his neck. Re-entered John Connolly's back, pierced the right lung, collasphing it, severad a wein artery and nerve, broke the right fifth rib destroying five inches of that bone, exited from the front of the governor's right these, he entered the back of the governor's right forearm. Caused

a commonuted fracture of the dyselin to the radius, a very thick bone, partially serered a vein artery and nerve, exited from the front of the governor's right wrist, re entered the governor's right wrist, re entered the Governor's left thigh, went all the way down to the ferry, the big hone in the thigh, bounded back, cans out through the same small hole in the skin, feel into the governor's clothing, from his clothing onto the stretcher and was fortuitously found a few hours later in the afternoon on Friday November 22nd 1963 at Parkland Memorial Hospital by a maintenance employee who was trying to get to the men's room and found the corridor blocked by stretchers. Now that is the single bullit theory. Hore aptly and descriptively entitled by the Mauren Commission critics as the magic bullit theory. It is indeed the most wondrous magical missile that has ever been described anywhere in the world. ....

JESSE CURRY WAS DALLAS POLICE CHIEF AT THE TIME OF THE ASSASSINATION.

YET IMPOSSIBLY WHILE ONE BODY IS BIGGER THAN THE OTHER, THE HEADS MATCH PERFECTLY, BEARING OUT OSWALD'S CHARGE -THAT HIS HEAD WAS PASTED ON AN INCRIMINATING PHOTOGRAPH.

Gaudet: Yes it did and it still does. Apparently there were many persons involved in a conspiracy for Kennedy. You had many persons who wanted him dead. Certainly the anti-Castro Cubans had a right to get into it.

Scott: Do you think Cuhans alone could have pulled off a crime like this?

Gaudet: No I dont think so.

Scott: They would have had to have backing of some sort.
