HIRED AS FREE LANCE PERFORMER BY RUBY. HAS NOT SEEN RUBY SINCE THAT
TIME. CANE DESCRIBES RUBY AS NON VIOLENT TYPE WHO MAINTAINS EXCELLENT
PERSONNEL RELATIONS WITH EMPLOYEES AND WHO HAD MANY FRIENDS IN
DALLAS PD. ALLEGES DUTY OFFICERS, DALLAS PD, WOULD SOMETIMES STOP IN
CLUB FOR A DRINK ON THE HOUSE AND PERHAPS AS RESULT THIS FRIENDSHIP,
RUBY WAS NEVER BOTHERED BY DALLAS PD WHEN HE PUT ON STAG SHOWS. RUBY
