Dear Editors,

If former Texas Attorney General Waggoner Carr is one of those who denies there is a conspiracy in the JFK assassination, and seeks to inform the public, he missed a golden opportunity in his letter of Dec. 19.

Mr. Carr said he is dismayed by those "who have no firsthand knowledge of the facts surrounding the JFK assassination but have a fixed opinion based only upon hearsay and their own personal opinion which they state as facts." He must therefore be quite upset about the recent books, periodicals, news broadcasts, and cartoons (Doonesbury Nov. 23 — Dec. 11) by conspiracy deniers.

He forgot to inform us that four of the seven Warren Commissioners the majority — expressed grave doubts about the Commission's findings within a decade of their report. He also forgot to tell us that Lyndon Johnson never believed the report he commissioned; and that the official policy of the FBI is that the case is not closed, a policy begun by J. Edgar Hoover himself. That's strange behavior for a group who had supposedly found the truth.

By any standard of historiography, the lone assassin scenario must be considered a minority opinion which is contrary to the known evidence.

Because he forgot to tell us this, he avoided the embarrassing fact that this lone assassin minority included Nazi sympathizers Allen Dulles, the CIA director fired by Kennedy over the Bay of Pigs disaster, and John J. McCloy, the former chairman of the board of Chase Manhattan Bank which had controlled Cuba's credit for half a century.

Dulles — we now know — exploited his post in the OSS to quash war crimes prosecutions of senior Nazi officials and German business leaders who cooperated with him in a series of clandestine schemes to secure U.S. advantage in Central Europe. And as U.S. high commissioner for Germany, McCloy — we now know — granted clemency to every single industrialist who had been convicted at Nuremberg.

Completing this loud minority was future president Gerald R. Ford, who betrayed the Commission by spying on them for the FBI, and who later pardoned Richard Nixon before he could be tried for high crimes and misdemeanors. At best, their judgement was poor.

Mr. Carr's own "Texas Court of Inquiry" into the Kennedy assassination consisted of only three men: Carr, Robert Gerald Storey, and Leon Jaworski. If Mr. Carr is sincerely "attempting to inform others who might wonder what the truth actually is," perhaps he could address a few other issues about which he has firsthand knowledge.

The first concerns Mr. Carr's apparent CIA connections through his board membership at the M.D. Anderson Foundation. The second regards Mr. Storey's apparent CIA connections as a board member of the International Education Exchange, a part of the CIA's Institute of International Education.

Storey was reportedly an Army intelligence colonel and a member in 1946 of the U.S. legal team at Nuremberg along with Leon Jaworski. Jaworski also sat on the board of the M.D. Anderson Foundation, which was reportedly "a CIA conduit."

In an apparently major conflict of interest, Dallas D.A. Henry Wade, Carr, Storey and Jaworski met with the Warren Commission in January 1964 to discuss allegations that Oswald had been an informant for either the FBI or CIA. Through the recent, partial release of CIA files we now know that the CIA had a high level interest in Oswald since at least 1960. The problem is not with the psychology of the American people. The problem is with the evidence. The case is open. The files are closed.
