

BACOLOD CITY, April 22 - President Marcos this afternoon said that government intelligence agencies are on the lookout for more communist suspects reported to have infiltrated the country lately.

The President made the disclosure in the light of the arrest of Luis Castillo, of the arrest of Luis Castillo, a Porto Rican, by the NBL Castillo claimed to have been involved in the plot to assassinate President Kennedy.

Reports Marcos said Malacafiang has been receiving reports of such infiltration but that he was not free to disclose them. He indicated that there was no breach in national security resulting from the incident. Castillo had reportedly made con-
