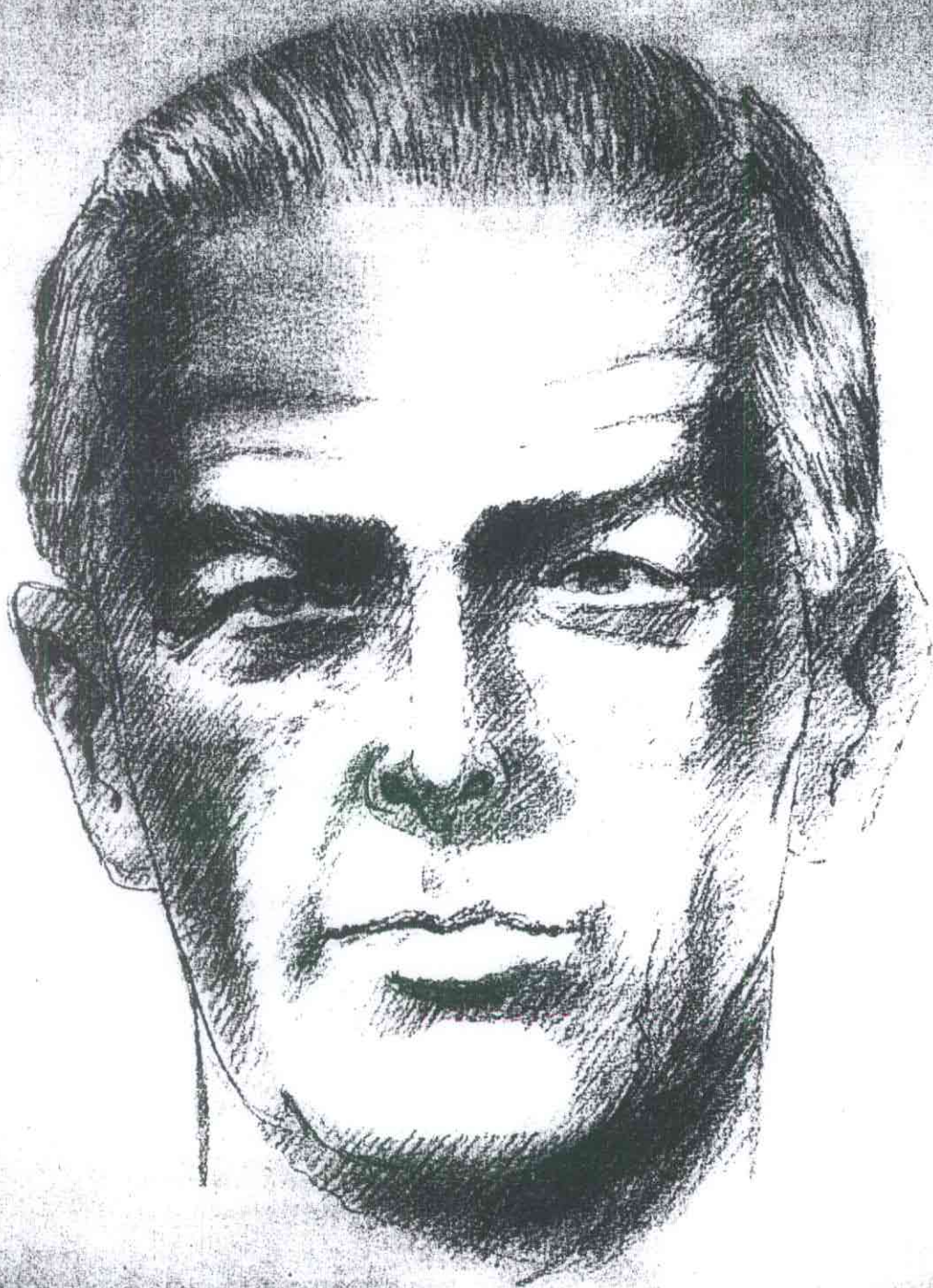

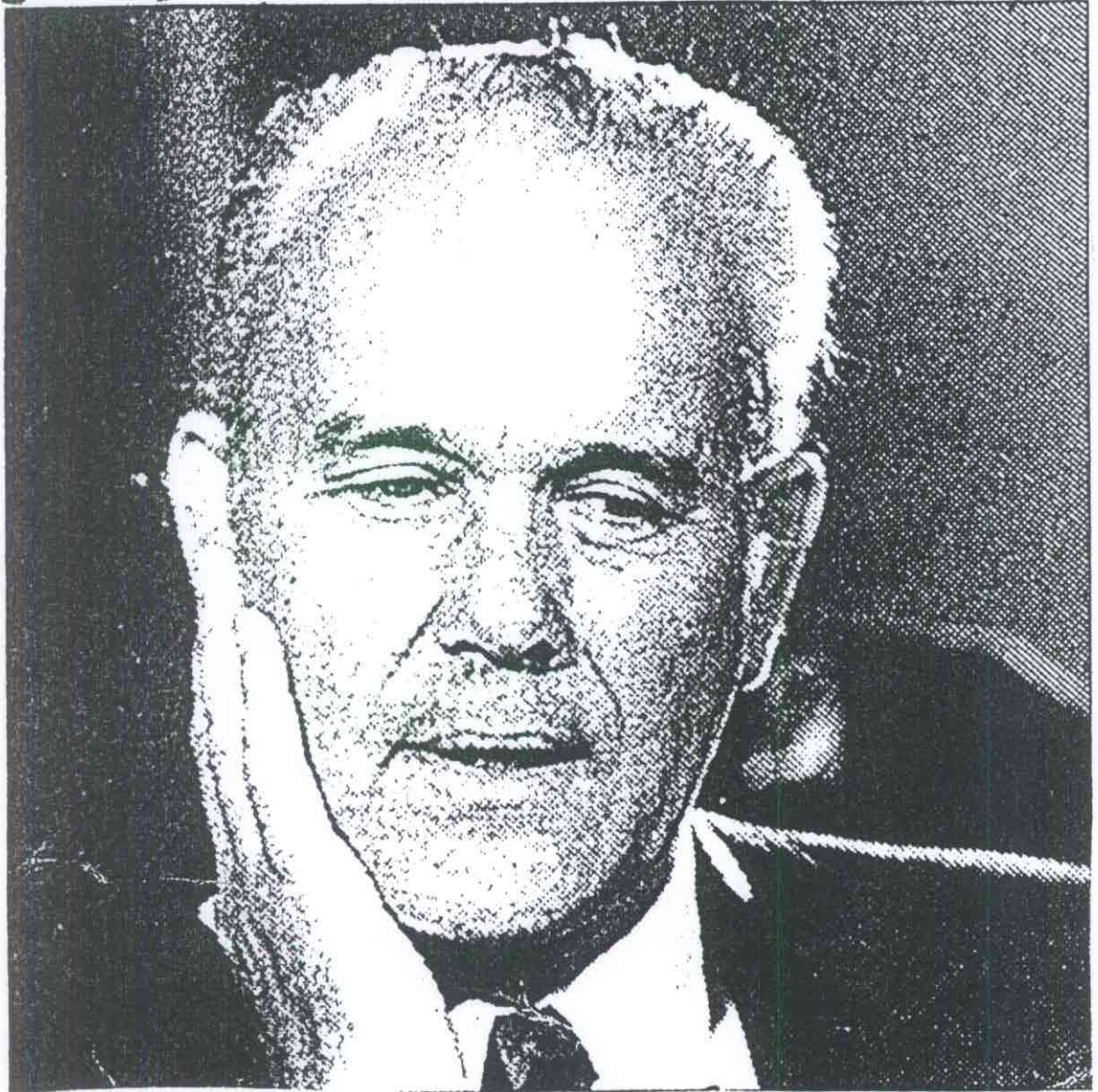

investigate John Kennedy's murder? The Post said that Phillips saw the transcripts of Oswald's conversation, and heard the tapes. Shortly afterwards, the CIA destroyed both the tapes and the transcript. It seems very peculiar that a week after someone is alleged to have gone to those embassies the evidence of the visit would be destroyed, especially since the translator said that the transcript was so important that they wanted it made on the spot.

Destruction of that evidence would fit with the fact that the photograph of the man the CIA claimed was Oswald entering the embassy was not of him, but this fact did not establish itself for years, until the photograph was released.

Phillips went out of his way to champion this story of Oswald in Mexico. Why was he so intent on implicating Oswald in some sort of connection with Cuba or Russia, and then had nothing to back it up? Phillips was quick to go to *The Washington Post* with this story in 1976, but why did he not go to the FBI and the Warren Commission in 1963? The Post said that a partial transcript was given to the Warren Commission but that "For unexplained reasons they failed to include Oswald's offer of information and his suggestion that the Russians would want to pay his way to the Soviet Union." The FBI was told only that a Lee Oswald had made contact with the Russians. The reason was that the rest of this was fabricated to bolster the case against Oswald, making him out as a leftist. The CIA had told the Warren Commission that it had only learned of most of Oswald's activities in Mexico City after the assassination.

Senator Richard Schweiker identified Phillips as being "Maurice Bishop," a CIA operator who was accused of trying to get a Cuban to implicate Oswald in Kennedy's murder. We believe that this was part of laying the false trail which helped frame Oswald as the patsy in the assassination. Other evidence implicates "Bishop" in the assassination of the President, and it may very well have been that Phillips was involved.

Unfortunately, the House Committee refuses to release any information about its long interviews with Phillips, or the

report on its trip to Mexico City to investigate all of this. Why not?

It would seem that David Atlee Phillips of Fort Worth, the head of his own CIA as he ran the Association of Retired Intelligence Officers before his recent death, held a key to the assassination.

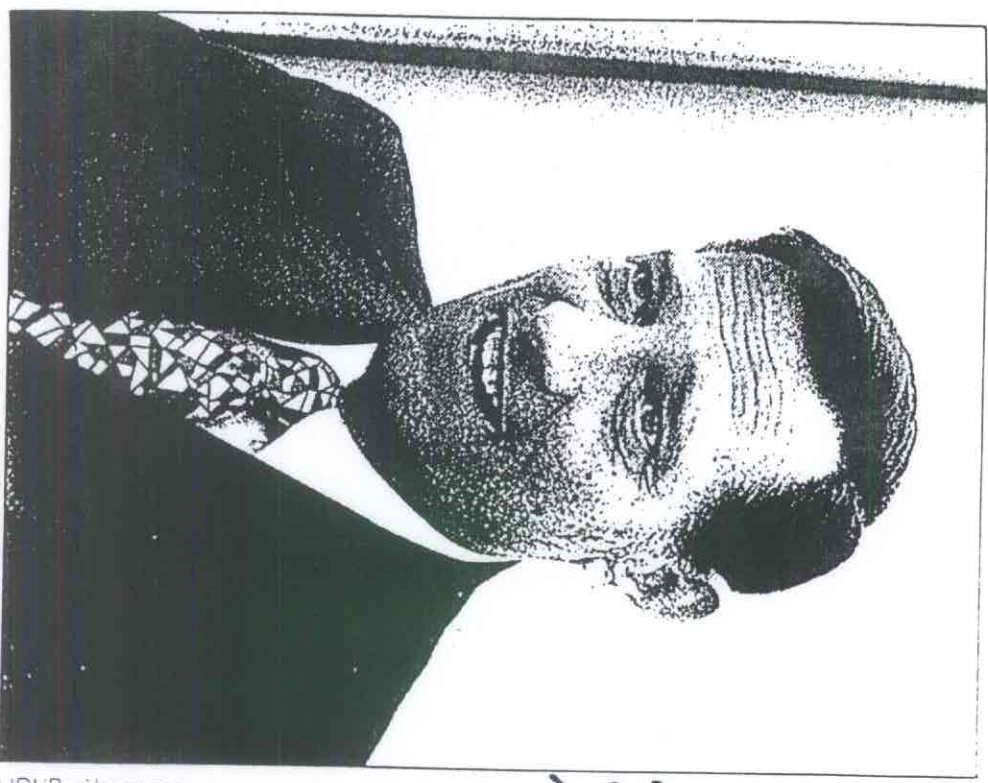
