
Dear Mr. Callum,

I had to hire someone to be with her when I am not and at the least that is three full mornings a week when I have kidney dialysis. I have also had to take over what my wife had done and I am ill prepared for that! What this means is that I've had to abandon normal correspondence. The time that is not taken up with medical needs I want to use, to the degree possible, on continuing writing. People who want to come are still welcome, particularly old friends. We enjoyed such visits each of the days of the past weekend but it also left us even further behind.

So, please do not expect me to respond under these conditions. It is now too much for us. And both my wife and I are older than your mother was.

Dear Dr. Crenshaw:

Please allow me to introduce myself. I am a Kennedy assassination researcher and am an attorney in Ohio and licensed in Florida. Recently, after a long hiatus, I began pursuing some new leads in the case upon renewed interest.

I appreciate your publication "JFK Conspiracy of Silence" and the resolute withstanding of the disingenuous treatment you received from the people at JAMA concerning your role as a witness.

I cite to you a passage at page 74 of your own book: **"The patient was logged into the register as patient No. 24740 at 12:38 p.m. Governor Connally was logged in as patient No. 24743, an indication that other patients were being admitted and treated in the emergency room during the time the President was being wheeled in."**

I do not know if you are aware that there were published reports and witness testimony of the wounding of a Secret Service agent who was in the entourage and which has never been resolved. Recently, Vince Palomara, a published researcher has pursued this lead. Further, I direct your attention to Police Chief Curry who at page 32 of his "JFK Assassination File" states: **"The Secret Servicemen seemed concerned only about the President. Governor John Connally was bleeding profusely. His wife Nellie looked on as the attendant were trying to lift the Governor onto a stretcher. He had been on the small seat just in front of Kennedy and had to be moved out before the President could be reached."**

With this information, is it not intriguing how the President was logged in prior to the Governor and two interceding other patients given the grave condition of the Governor. Can you help in identifying all patients in the series 24739 through 24744 particularly the two patients logged in between the President and Governor?

# Louise Cellura, 85, longtime political activist

**SHAKER HEIGHTS** — Louise H. Cellura, a hostess at the original Golden Bowl restaurant in Little Italy for many years and a longtime political activist, died Monday at the Somerset Point nursing home. She was 85.

Mrs. Cellura had also managed the Burrow's book store in Shaker Heights and was an original staff member of the Ohio Lottery Commission. She volunteered at St. Cecilia Catholic Church and school and at Cathedral Latin School.

She was born in Cleveland and attended John Adams High School. Known for her out-

going personality, she enjoyed cooking and entertaining.

She worked at the restaurant while it was owned and operated by her late daughter and son-in-law, Demetra and Henry Sciulli. The customers included visiting Hollywood actors, leading politicians and major league ballplayers. Mrs. Cellura was not awed. When she was young, she had shaken Babe Ruth's hand during a Cleveland Indians game at League Park.

Mrs. Cellura served at various times as a precinct committeewoman for both the Democratic and Republican parties. She ran the Woodland Ave. headquarters for John F. Kennedy's campaign for president in 1960.

She lived in Shaker Heights. Her husband, Frank, died in 1966.

Mrs. Cellura is survived by a daughter, Donna J. Brant of Beachwood; sons, Angelo of Phoenix, and Frank Jr. of Columbus; six grandchildren; four great-grandchildren; a sister; and a brother.

Services will be at 1 p.m. today at St. Dominic Catholic Church, 19000 Van Aken Blvd., Shaker Heights.
