Let me, at Jack (ooke's request, suggest that you open up with Deems by backgrounding your U. S. Senate and (ongressional experiences, as well as other ego-tootings that thrill the image-muckers. While I'm sure your rhetorical capacity will dazzle the clot, there's nothing like a chest full of dangling dandies to distract the kind of idolators nurtured by the archaic Hearst Syndrome.
