Not only should the book have one and does everyone need one, but in particular, I am so deep in all of this and so tired atop that, I do hope that by then one will be available.

I see no resson to discuss business affairs with Hal. He has been a good friend and helpful, but not in a business way. I understand how he feels about the various thieveries. We dispussed it when he phoned several days ago to ask for the Hughes picture, which I sent him. He also was present when I told Turner in confidence about TIGER and knows that Turner used that then used it. But, Garrison did the seme thing, and Turner could have gotten it from him.

Your description of the Berkeley arb does not offend me. I have seen a couple of issues. They did, however, help me with WHITEWASH and when I consider the eminences, I am happy with anything they'll do. They reach about 50,000 people, a fair proportion of whom can be motivated on this subject. However, when Hal phoned he did not ask about the Garrison introduction. I feel I'd have to leave that up to Parallax, maince I am not the exclusive publisher in this case. I'd like to think they'll be able to find a good use for it. I think you'll find him cooperative on coordinating. I say, he did remarkably well for me and we had never Te did it entirely on principle.

On CBS, It just occurred to me I have a couple of letters in which you may have some interest and for the file. Please not titles and dates.

I have the envelope in which the limited edition of WHITEWASH was mailed tack to me. It is postmarked 4/6/66. In response to Midgaey's letter(which, I think, legally, raises an entirely new aspect, for it is indication that my proposal is exactly what they ultimately did, save for their own finking doctrine), I sent the copy of WHITEWASH back to him and said the time might come when'd he'd need it. In any event, I generously supplied CBS with copies of that and all subsequent books. Williams was so interested the night I spoke to him in his NYC office that he suspended the screening of some specials they had maxe (good ones, on free trial). Maybe this will help, huh?

Guy named Larsen running it.

It is only a hunch and may be wrong, but one thing that may be keeping John silent is something he had earlier told me he'd initiate, a study of some kind by a research groups for one of his clients who might be able to use my material, which would have the effect of getting whatever he wanted studied done impartially and at no cost to me.

Gotta get back to writing, which has been slow lately. I'm in thelest planned chapter of the untitled book. The completed chapters are titled in a way that will tell you little but maybe you can react: Introduction: Conclusions First.
