## Deer Gordon,

Do not be mislead by the sensetion-seeking headline, this is a very considerable legal victory for Garrison and quite an important one for me for from my non-legal understanding it seems that everything I have in my books, just about, is pertinent and admissable in evidence! I refer to the nine points on the second sheet.

And I tell you this for your information, not Dewnay's. It will be two we ke after you get this before he gets his papers, and he may or may not understand the significance of the decision. If he thinks as Joesten does, he will not. I see nothing wrong with your telling him that there has been a decision that makes everything in my writing pertinent, but I think possibly for the moment I'd prefer not to assist Joesten.

It also makes me more convinced that prospects should be better this time, that I will be right in waiting and chancing.

I am really confident now that Joeston does not have (if he does, it is worse) the 26 volumes and has nothing but an irresponsible, unbridled imagination to add to second-hand materials that he only partly comprehends. In glancing at the book this morning in the proper environment I found he quoted Kenny O'Don'ell's testimony from Time megazine, not his testimony. And I have found nothing to in any way change the appraisal I have given you and Horne.

Tuesday I go to New York to confer with John and Gallen of Farallax and seek a lawyer for a possible suit against Dell. I have yet to get an accounting, to get a cent for the 8,000 copies of the original edition of MHITEMACH they ordered, or any performance on their contract save publication. I return in time for a meeting with Fred Horne and his board of directors of Horne of England to see if they are interested in non-exclusive distribution of my first three books, probably largely by mail solicitation. I understand that some of the top Hearst personnel are interested in meeting me and I shall give them the chance.

Utherwise, there is nothing new.
