These procedures are going well (aside from a battle with the attility, which tried to spearate me from an unnecessary \$128.00, as though the money were my own! We'll have current by night, but what this does to my awful tyrping I can only imagine.

Time will tell about Raymar. I can tell you this: before I am finished he will not be happy about what I have done. If Dolan does the kind of show he can do and has done before I get out there, that sensitive moneynerve will hurt.

I did not get a single order from the Bowen show, and he certainly did plug the books (very little on PW, which is what I wanted).

I am happy about the sleeping arrangements you have made, for I was a burden to Hel and his friends. They were wonderful, bery tolerant, and he really wore himself out. Lete as " got to bed and early as I had to get up, he was later, for he had to go home, and he was up earlier, for he had to pick me up. He was wonderful! He didn't trust his car, so he borrowed one, too.

I find myself, in a way, looking forward to this. I hate to leave Lil alone with this mess, but I'll leave her enough work so she'll not find time hanging. And I want to get to slugging with some of those sanctimonious finks you have out there. I'll have a little bit on Joe Ball. Did you say Liebeler? Thatm too, including a few tapes of some of the things he has said.

The three bozers bit got no press here, none that I'm aware of.

Initial reaction to my requests for appearances were good. I got the TV show I want in Chicago and the clear-channel radio in Thila (where they have been declining to air ew Orleans stuff but trust me not to endanger Skaw's rights). However, a real good guy on WBBM, "arv's bosses' sister chear-channel station in hicago, has been ducking my calls. I'll try again a couple of times. Remember what I said about Harv: don't pressue him into doing anything that might be against his interest. What is and isn't happening in New York also has me unhappy. However, there is nothing I can do about it from here and, I fear, not much more I can do when I'm there. I put in a call to Workman at Parallax this morning. It was to have been returned in an hour. It is now almost five hours and there has been only silence. You jight thenk they were not depending 100% on me to promote this book. We have less than two weeks left and we are not even asking for specific time:

Bringuier will screen when I am in New Orleans. hope the papers and TV hear him. And from the very beginning, I have feltthat this is something I am intended to do and that I will be able to do it. And do I welcome help, even only the offer.

As you can see from the enclosed, given a half hour to spare, when I cannot do something else, I can always return to the battle.

I doubt if we'll get the books wrapped in time to mail them tonight, for the oackaging dept is in the very dark basement. They will go out tomorrow, with prebably a few extras if I can find the right size box. The P.O. closes at 5 p.m., and it is now after 3. There will be a supply of 0 in N.O. at the wholesaler's in S.F. that we can tap. I have only glanced at the book, which arrived today. The prologue has been cut heavily, so heavily that I think they cut out everything for which they asked me to write it. I'll have to get copies from them, of the uncut version. Phoebe and ooke, if not J., may want to read it. I fears the cutting excluded all of the mailing history of the ms and the Dell contract breaking. In a glance I noticed that, when they decided to do it under their "Canyon" imprint, they did not whange the writing, which reads "Parallax". If this is the kind of editing they did, let your nails get long so you have something to start with.
