Dear Steve,

When writing is less difficult for you (and I wish my handwriting were as legible as yours, impaired, is), tell me how what happened. I certainly hope nothing fatal happened to your treasured steed.

The enclosures are, I think, self-explanatory. I had already addressed and stamped the envelope.

What you said is exactly right, as quoted in the story - as I see it and have from the first said. The story cannot say everything you did, but I'd like to suggest a formulation: the investigation must be entirely in public, with no secret evidence, and by a body with both the power and the disposition to compel attendance, the production of records, and the willingness to punish perjury.
