¹t is elways good to hear from you. The letter arriving today tell me I have referred several people to you at the wrong address! I hope their letters ultimetely reach you. I should have checked the address but trusted my memory.

I do not now know my immediate plans. I am so utterly fatigued and yet so determined to publish the work have already researched that I try and stay as close to here as I can so that I can complete it and then rest a bit. There is shance I may be wanted as a witness. I would, of course, like to be in N.O. for the trial. However, I am as of now \$29,000.00 in debt, and there are two luxuries I cannot afford; spending other people's money when it is not essential and taking time from work. This is an indefinite enswer, but it is the best I can now give. I also think the trial will be after September, possibly October. I also hope so for other reasons: my New Orleans book will be out soon, and with any luck and attention, it can help himbeckstop him. It will have reference to the more than 300 pages of documents I have on this aspect alone. I will not now be able to publish them. Cost.

This is the book called CIA Whitewash. It is now, again, Oswald in New Orleans, with the subtitle, Case For Conspiracy. The CIA whitewash line will be some place on the cover. Parellax is publishing, pocketbook size. Their normal distributor, on even the anti-war and anti-LEJ things they print, S&S, will not hendle this subject. Se, distribution will be improvised.

Please send me a copy of your FCC complaint sgainst CBS. I am working on a much broader basis and have other things that, I think ,make it a stronger case. I intend also to go there, but 1 have not been rushing because I keep getting letters through the CBS chain of legal command. I've been sending Maggie copies. I am also going against NBC, AP and UPI on a basis you, I think, cannot. I wish I'd known earlier. have gone over the CBS script and made page by page enswers, but in some cases on a personal basis, which I thick strengthens rather than Weakens. Also, VS Merv Griifin, Today and a miscellany of stations. Please keep me posted. I send "aggie copies of everything on this. 1 think I've made a few dents here and there. Have you received any communication from CBS you heven't sent me.

It is doubtful that the facilities will permit engone to assure you a place in the courtroom. I'd write Jim Alcock first if I were you, Let me know what he says. I suspect that in this case the decisions will be made by the judge. If it is possible to do something without simply badgering, I'll be glad to. Your presumption is correct shout the tape, but with no Liebeler they didn't need it. I didn't know you had sent him a copy so I did. Only for use as evidence was the original needed.

I would like to be able to make another trip out that way the end of September, but the same problems, financing, will exist. I think that although small I'll be able to get Perallax to help. Any chance of lining up some paid-for speeches? I'd like to use the new material, not go over what everyone else has been chewing for so long. There is newm material and it should be out. I'd not be unhappy about a few debates, and we can issue a few challenges, like to Liebeler and Ball. If this is feasible, I cannot do it before the List week of September. I'd like to have my present writing done by then, but there are now too many interruptions.

I received your message from Bill about Alcock needing my recorder and original tapes. I wrote him saying he could have the tapes with no problem but that I didn't want to send the recorder unless it was necessary. I haven't heard from him yet (10 days). Maybe Liebeler's refusing the subpoena had something to do with it.

So as it stands now, Maggie, Bill Turner, Te, and a couple other members of the committee will be in New Orleans for the trial. How about you?
