A PETITION

To Renew the Investigation of the Assassination of John F. Kennedy

WHEREAS: The Report of the President's Commission on the Assassination of President Kennedy (Warren Commission) has failed to prove conclusively to the American people that one man, acting alone, was responsible for the death of the President.

WHEREAS: Evidence relevant to the assassination of President Kennedy has been made unavailable to the public until September of the year 2039 A.D. by executive order.

WHEREAS: The citizens of the United States of America are greatly concerned that the assassin(s) of John F. Kennedy be identified conclusively.

Therefore, we, the undersigned citizens of the United States of America hereby demand that:

- (1) The Congress of the United States of America institute a new investigation of the assassination of John F. Kennedy to be conducted by qualified non-government lawyers, criminologists, pathologists, et.al., employing advocate procedures in open, public hearings.
- (2) The new investigative body be empowered to examine all of the evidence including that which is now classified, and that all the evidence be subsequently published or otherwise made available to the public.
- (3) The assassin(s) of President Kennedy be identified conclusively.
