NEW ORLEANS

Mark Lane has been in New Orleans and has been briefed in detail by Jim Garrison. He has told the committee that Garrison knows and can prove who planned the assassination. But, Lane says that Garrison will not have the legal jurisdiction to arrest all who are involved, and for that reason, he feels that it is more important now than ever before that we continue to press for a new investigation. That we will do.

Following are the comments of some of the major critics of the Warren Report:

Mark Lane -

"I sat there stunned, absolutely stunned as the evidence was assembled before me by Mr. Garrison...the evidence is massively detailed and shows that...a very powerful domestic force was involved..."

Vincent Salandria -

"From what I can ascertain from a distance, D.A. Garrison bids well to become an important figure in history. He appears to have those ingredients so lacking in today's public officials, to wit, courage, skepticism, and honesty. Mr. Garrison seems to have a hierarchy of values that places truth at the pinnacle."

Harold Weisberg -

"My opinion of Garrison is that he is sincere, right, and pursuing what I had already outlined in Chapter 11 of the first book and 7 of the second."

Sylvia Meagher -

"I am very hopeful that when Mr. Garrison reveals his evidence it will conclusively resolve this great crisis of confidence and will conclusively demonstrate that the critics have been absolutely correct in their repudiation of the W.R. and their certainty that a political conspiracy plotted and executed the assassination."

Marjorie Field -

"Among the few statements made to the press by D.A. Garrison were two which indicated to me the comprehension and integrity with which he is approaching his investigation. The first was, "Let justice be done though the heavens fall." The second was, "I have no evidence to show that Lee Harvey Oswald shot anyone on Nov. 22, 1963."
