## License & Registration Please (Pt II)

Palmer would offer cooperation of Manchester's statements, but because of the hearsay rule, this could not be bought out at the Clay Shaw trial.

After Palmer's request for the vehicle identification on the black Cadillac, he asked Manchester what he had found out. Palmer later testified before the HSCA that "(Manchester) had told me he had gone over and talked to the people in the car and they were not federal men: that the man was a representative of the International Trade Mart in New Orleans, and I said, 'What is he doing here?' and he answered, 'Trying to sell bananas, I guess,' and laughed. After that I paid no more attention to the car."

But Palmer did pay attention to the young white man who waited patiently in line all day. After taking his afternoon break at about 3:30 (and again noticing the black Cadillac outside), Palmer once again set about processing the applicants. When he eventually came to Oswald, he asked for identification and Oswald produced what Palmer later described as "a separation paper from the Marine Corps,

and it had the address on it, ten-something Camp St., New Orleans. So I asked him where he lived. He told me he lived at the East Feliciana State Hospital. And I asked him who he lived with. He told me—I'm not positive about this name—but I think he said Doctor Pierson." (There is some ambiguity about the name of Oswald's

investigator, Lynn Loisel, that Oswald stated that he was living with a Cuban Doctor, Frank Silva." The HSCA took these allegations seriously and subpoenaed the medical personnel records from the hospital for staff employed there in 1963. Ironically, both a Doctor Malcom Pierson and a Doctor Francisco Silva are listed in

these records as being on staff in 1963.) Palmer then asked Oswald why he wanted to register to vote in Clinton and Oswald told him that he wanted a job at Jackson Hospital and he was advised that he would have a better chance of getting the job if he was registered to vote. Palmer attempted to reassure him that he didn't need to be registered to get a job there. "In fact, you don't need to

be registered at all to get a job there." Palmer continued, "I know people out of Mississippi that are working

### REVIEW BOARD HOLDS SECOND MEETING

The second public meeting of the JFK Review Board was held on Tuesday, July 12, 1994 in the National Archives building in Washington D.C.. Review Board members questioned Archivist Mr. Steve Tilley about individual agencies responses for documents under the provisions of the JFK Assassination Material Act of 1992.

Mr. Tilley's, who is the point man in the Archives for this collection, responded that, as of this date, many agencies have been forthcoming with documents but are also using withholding exemptions

mysterious Doctor. Dick Billing's, who at the time was a reporter for Life magazine, wrote in the journal he kept of the Garrison investigation that, "It was determined by Garrison

at Jackson." Oswald thanked Palmer, walked outside, and got into the back seat of the waiting Cadillac—and all of this was duly noted by Marshall Manchester.

When Palmer closed up shop at a little past 6:00 that evening, he stopped by the drug store on his way home. As he was entering the building, Clerk, Gloria Wilson, said to him, "Mr. Palmer, your CORE workers are riding in better cars than you are." Palmer said, "What do you mean?" Wilson answered, "Well that boy that stood in line all day with those Negroes got in the back of the black Cadillac and left with those two men who were sitting there all day." (Ms. Wilson died before the Garrison investigation started.) It should be noted here that throughout that day, as Palmer took both his breaks and his noon meal, he had more than one opportunity to study the occupants of the mysterious black Cadillac. And later, at the Clay Shaw trial, he too would identify photographs of both Shaw and Ferrie as the occupants of that car.

Many researchers subsequently writing about these events, have tried to build a case for Guy Bannister as the driver of the black Cadillac, and some have also written that the attempted penetration of the CORE registration drive in Clinton was an early example of the FBI's COINTELPRO operations. But it is now clear that, with the newly released HSCA testimony of Mr. Palmer, coupled with his testimony at the Saw trial in New Orleans and buttressed with all the other eyewitness accounts of this event, that these speculations are wholly without merit. When Palmer was shown a photograph of Bannister by Assistant D.A. Andrew Sciambra at the trial in New Orleans, he responded:

Q. "Do you know who the individual in that picture is?"

A. "Yes I do."

Q. "Who is it?"

A. "Mr. Bannister."

Q. "Where do you know Mr. Bannister from?"

A. "I knew Mr. Bannister in the service in WW II."

Q. "Is there any possibility that Mr. Bannister could have been the person in that automobile"

A. "I am sure I would have know Mr. Bannister if I had seen him."

Further information on this point was elicited by HSCA counsel Blackmer during this exchange taken from Palmer's deposition:

A. "I saw Guy one time at the Legislature down here. It must have been either—I think it

was 1960—I run into him at the Legislature."

Q. "And you recognized him?"

A. "Oh yes. I knew him."

Q. "Did you see anyone who resembled Guy Bannister in that black Cadillac parked across the street from your office?"

A. "I couldn't say that anybody who looked like Guy Bannister was in that car."

Q. "Had Guy Bannister been in that car, did you get a good enough look at the car that you would have recognized him?"

A. "I would have recognized Guy Bannister, I knew Guy well enough that I would have recognized him."

Even HSCA Chief Counsel, G. Robert Blakey, knew he was backed into a corner on this point, and didn't even attempt to place Bannister in Clinton in the HSCA final report. However, he tried to soft peddle Shaw's presence there with this bit of sophistry found in that final report: "The Committee found that the Clinton witnesses were credible and significant.....it was the judgment of the Committee that they were telling the truth as they knew it.....If the witnesses were not only truthful but accurate as well in their accounts, they established an association of an undetermined nature between Ferrie, Shaw and Oswald less than three months before the assassination.....(The Committee) was therefore inclined to believe that Oswald was in Clinton in late August, early September 1963, and that he was in the company of David Ferrie, if not Clay Shaw." Blakey later wrote in his 1981 book, "The Plot To Kill The President," "The evidence we found persuasive was the testimony of six residents of Clinton, Louisiana. It was the Committee's considered opinion that the witnesses were honest folks."

This episode did not end that day in Clinton, however. On the following day, Oswald, now informed of the insignificance of registered voter status, applied for work at East Louisiana State Hospital in Jackson. Around noon that day, Bobbie Deaton, a receptionist at the hospital, directed a young man, who she would later identify as Oswald, to the personnel office. Further documentation that Oswald applied for work at Jackson hospital is supplied by the testimony of Maxine Kemp, which can be found in HSCA files. Approximately one year after the assassination,



Mrs. Kemp was in the personnel office at Jackson and heard a report on the radio concerning Oswald. Having heard rumors that Oswald had applied for work at the hospital, she decided to check the files. Upon checking the application files she indeed found a file titled, "Oswald, Lee ." She noted that the application was on the older forms that were in use in 1963, but had little time to look at other sections of the document; such as references, past employment, residence, etc., before being interrupted. When questioned in the late 1960's by investigators from Garrison's office, she once more attempted to locate this file but it was no longer among the existing records at the hospital. Mrs. Kemp did remember that a co-worker, Dale Booty, had also seen this file. When HSCA investigator, Robert Buras, was following up on this story, he contacted Mr. Booty only to be told that he could not remember this incident. Mr. Booty even went so far as to repeat a common mantra invoked by many witnesses in this case....., "I prefer not to get involved!"

During the HSCA questioning of the Clinton / Jackson witnesses, another important point was educed. Just outside Jackson, Louisiana was a very large tract of land called Marydale Farm. Palmer, Manchester and McGehee were all familiar with this unusual "farm," for it employed an unusually high amount of Cubans. All of these individuals stated that Marydale was owned by a Mr. Cobb.

During cross examination of Shaw during his trial in New Orleans, assistant D.A., James Alcock, asked Shaw about this farm. Shaw confirmed that he knew of this farm and that it was, in fact, owned by Shaw's associate, International Trade Mart President, Lloyd Cobb.

As a final point, there is also testimony taken from Lieutenant Francis Fruge of the Louisiana State Police, who was detailed to work with the Garrison investigation in 1968. As part of his duties he participated in interviewing the Clinton / Jackson witnesses. In an interview conducted by the HSCA, Fruge commented that the eight witnesses who testified during his investigation were "completely credible," which echoed the findings of the Select Committee. Fruge elaborated further, stating, "...there were others from the area who did not testify, but who were equally credible and enlightening as to the visit of Ferrie, Shaw and Oswald to the area in 1963."

With such a wealth of testimony putting Ferrie, Shaw and Oswald together in Clinton just a few short months before the events in Dallas, it is now unconscionable to: perpetuate the erroneous assumption that Guy Bannister was involved in

these machinations; to assume that these events were some unexplained early attempt at a COINTELPRO penetration of CORE activities; or to downplay the significance of Oswald's direct contact with Dr. 's Malcom Pierson and Francisco Silva at Jackson State Mental Hospital.

This story is a perfect example of how important the files that are being currently released under the provisions of the "JFK Assassination Materials Act" are to our correct understanding of the true nature of the events surrounding the accused assassin. It also stands as living proof that there is no truth to the rumor that, "There is nothing new in the files!"

by claiming that some documents are outside the assassination document sphere.

The Board estimates that it will take between 2—3 years to accomplish the task at hand and further stated that the search for an Executive Director (which has not be completed yet) is important to Federal agency liaison functions.

The Board also mentioned that it will be September before their newly hired staff of the Review Board will start work and October before the Board receives full Congressional Appropriation.

A series of public hearings are scheduled to define the term, "Assassination Record." The first of these hearings will be held in September, in Washington, D.C., the second probably not before early next year. Additional sites for the remaining public hearings have not been set.



Steve Tilley anticipates 3 releases of additional files in the Spring (April or May). These will include;

- 1) April—Full disclosure of LBJ tape recordings at LBJ library.
- 2) May 3—(A) FBI LHO files from '62 series, with physical evidence included.  
(B) Field office files from the FBI.  
(C) Church Committee files (7 additional boxes).  
(D) Department of Justice—Litigation files
- 3) May 10—Main field office files on LHO.

When questioned on general response to requests for files, Mr. Tilley stated that "the Archives doesn't pressure agencies for files." He also stated that interest in these files remains high and reiterated the point that some agencies have postponed handing over documents, claiming that they are outside the sphere of assassination documents. He also revealed the fact that the Archives must release files turned over to them no later than 30 days after they receive them.

#### **New records to be released soon:**

Mr. Tilley gave an estimation on files that should be ready for release in the near future;

- 1) The remaining field office files of the FBI relating to the Pike Committee investigation.
- 2) 10 more boxes from the Church Committee (Executive session transcripts included).
- 3) An additional 70,000 pages created by the HSCA in their review of CIA documents.
- 4) An additional 70,000 pages of original CIA documents from the HSCA microfilm collection are nearing completion of the review process and are being readied for release.

Congress itself will review all Rockefeller, Pike, Church and HSCA documents, as they have the oversight responsibility on these documents and thus—the final word. The current Committee on Intelligence (through the office of the clerk) will oversee this function for the Congress and Mr. Tilley is in contact with the staff of this committee.

Board member, Mr. Kermit Hall has been very aggressive in regards to intelligence foot-dragging. Chiding them when he said, "We have Less than a box from the NSA. They have postponed a great deal of material."

Other information coming out of this meeting that is of some interest is that the Army has now turned over documents on the testing they did on Oswald's rifle (with only 2,500 pages being held back). But most importantly, it was revealed that Army counterintelligence in Eastern Europe does have some files on LHO

### **VHS TAPES**

A flyer was received at CTKA headquarters announcing a new VHS Tape series to be produced on this case. Entitled simply, "The JFK Assassination," Volume 1 in this planned four-part series is ready to ship today, under a limited "Pre-Production Offer." Directed by Dale K. Meyers, an Emmy award winning animation director, this video has a running time of 12 minutes, is in black and white and retails for \$75.00.

"The Dealey Plaza Shooting" is a 3-D computer generated micro study of a full-scale mathematical model of JFK's fatal motorcade trip through Dealey Plaza. ## "SPECTERS FROM AN UNFINISHED PAST — RETURNED"

*The following is the first in a series of excerpts of chapters from an upcoming book on the LeGon and DeMhorenschildt familys written by Co-authors, Krissa Kearton (the only child of the late Jeanne Legon Demohrenshildt) and CTKA member, Arthur Penada, Esq.*

*This book is slated for publication in 1995 and PROBE will keep it's readers up-dated on the release date.*

My mother had struggled to put behind her the pain of the previous 25 years: the unfortunate and per chance (so I was told) acquaintance between herself, her late husband (my stepfather) George DeMohrenschildt, and Lee and Marina Oswald in 1962-63; and the blacklisting she and George experienced in being ostracized from the Dallas elite society in which they had thrived (and I had know in my adolescence) before the world, our world, was turned upside down on November 22, 1963.

This, though bad enough to ruin any family, paled in comparison to the devastation we felt due to George's death, ruled an "apparent suicide," in 1977. Since then, mother had fled Texas for California in 1989, and tried to escape from her shattered existence through alcohol and isolation from most people. Even, at times, from me, her only daughter.

Thus, when a copy of the infamous "backyard photograph" of Lee Harvey Oswald was returned to mother, she abandoned it like an evil stepchild returned from exile. One of the few persons from Dallas with whom she had kept communicating



was Ferris Rookstool, who mother referred to as an "FBI agent." (Only after mother's death did I learn that he is only a staff photographer for the Dallas office of the Bureau.) Rookstool and my mother had met at a banquet given in Dallas by the "Grassy Knoll Gazette" back in 1983. It was Rookstool who later returned the infamous "backyard Photograph" to my mother late in 1989. (This photo had been in the custody of the House Select Committee On Assassinations in 1977-79. I still don't know how Rookstool obtained this photograph in the first place.)

Mother gave this photograph to a neighbor in Los Angeles, one of her few close friends on the west coast. Perhaps mother felt that by hiding this all too graphic reminder of an awful past, she could distance herself from it's memories. But the shadow of the assassination of the century is a hard one to be free of—ever! Especially for one so closely acquainted with it, or to one of the principle players in it, Lee Harvey Oswald.

And so it was that, in December of 1991, mother and I watched a screening of Oliver Stone's "JFK" in a theater in Los Angeles. The film had just opened amidst a hurricane of controversy, and millions of people, world wide, were given an opportunity to relive the events of the fall of 1963. For my mother, the controversy and intense interest in the case was only the beginning.

Ferris Rookstool started calling my mother from Texas shortly after the release of the film "JFK." He asked her to let him have the "backyard photograph" back again. Promising her money, perhaps lots of it, if she would return the photo to him right away. In retirement from her dress designing profession for some time, she was living off of her social security income and the offer of substantial cash sounded good to my mother. Just before her death, she had spoken of obtaining a new car with some of the proceeds she expected to receive when Ferris sold the photo for her.

But first, there was panic! When Ferris first contacted mother requesting that she return the photo, mother called her neighbor and asked for the photograph back. But the neighbor couldn't find it. More precisely, she had forgotten where she hid it. Her neighbor, who is apparently apolitical, professed that she hadn't seen the film "JFK," had never read any of the books on the case, and didn't realize the importance of the photo or it's potential value.

Upon discovering this situation, Ferris Rookstool rushed to the west coast: to help locate the snapshot that the Warren Commission, and, with some of it's usual equivocation, the House Select Committee On Assassinations, said was

taken of Oswald by his then wife, Marina Prusecova Oswald (now Marina Porter).

In recent interviews, Marina is reported to have said she did take a photograph of Lee in such a pose, but that it was from a different angle than that as depicted in the infamous photo. Many researchers and critics have questioned the authenticity of this photograph over the years.

Eventually, the photo was located inside a drawer at the neighbors house. My mother, encouraged by another California friend, one who follows research into the assassination, contacted a local newspaper reporter who agreed to make a photo reproduction of both sides of this snapshot (purportedly bearing handwritten inscriptions by both Lee and Marina). But mother changed her mind, presumably on the counter-advice of Ferris Rookstool, and copies of the photo were never made.

Rookstool convinced her to drive him up to Sacramento in the late 1970's auto she had bought with her from Dallas. They traveled all the way across the California Central Valley to the home of another of her late-life associates, Nina Behrens, her cousin.

It was Nina and her husband, William Behrens, that had previously convinced my mother to cash in her only certificate of deposit (Most of the remainder of the property left by George to my mother after his death in 1977) and lend them \$20,00.00. The Behrens had made a verbal promise to pay this loan back, "when she needed the money."

My mother was so diminutive in stature that she normally had to look through the steering wheel to see the road as she drove. And, alas, she had the habit of carrying a flask with her whenever she was away from home. I can only imagine, with dismay, the image of her driving all that way, at the age of 78, with the much younger Rookstool comfortably relaxed in the passengers seat. (She had told me that when she moved to California in 1989, Rookstool had told her that he had once been shot in the line of duty.) I can only imagine what stories Rookstool told her on the long drive from Los Angeles to Sacramento. I do know that she still thought he was an FBI agent and he did nothing to dispel that notion.

I have been informed that Ferris Rookstool was desperate to convince my mother that he had "definite proof" that Oswald had acted alone in killing President Kennedy, that he told her he needed the photograph to help "prove" it, and that she was promised "a substantial sum of money" if she would permit Rookstool to sell it for her.



Predictably, my mother's car broke down in Sacramento, and whatever plans Rookstool had up his sleeve were put on hold as the repairs were completed. But not for long!

As far as I am able to determine at this point, my mother returned to southern California with the photo still in the possession of her Los Angeles neighbor. However, mother was persuaded to return to the Sacramento area in December, 1992, and at this time the Behrens claim to have gotten her to sign some legal papers, including a Will, giving them total control of her property. All of this occurred less than 30 days before my mother's death in Los Angeles, on January 21, 1993.

Since that time, I have been denied access to any of my mother's property, including my own personal items that were in her possession. The Behrens have treated me as if I was a pariah, rather than Jeanne DeMohrenshildt's only surviving daughter. Indeed, the only child she ever had.

Meanwhile, after mother's death, the Behrens had control of all her property and Ferris Rookstool had, not only the photo, but other assassination-linked items as well which the Behrens had given to him. Her estate has received nothing for the photo or other items.

The purported Will the Behrens supposedly had written up on her Christmas visit in 1992, has never been filed in any court for probate.

The only things I have of my stepfather's are a few of his correspondence and some old bank records that date back to the 1950's.

But even this woefully incomplete record contains some very intriguing items.

## TAHOE TRIBUNE'S THUNDEROUS TRIBUTE

"There's no way a single gunman could have fired the shots that killed President John F. Kennedy in 1963, and a lazy and manipulated media has blown

the story for the last 30 years." So began the write up that CTKA garnered from writer Jeff DeLong in the Tahoe Daily Tribune after it's much publicized "Teach-In" at the Lakeside Inn in South Lake Tahoe, Nevada last month.

CTKA affiliate member Mike McGinnis was able to get local press coverage for this presentation and due to the expertise of the presenters, Dr. Gary Aguilar, Jim DiEugenio and Dennis Effle, the following excerpted article contains some much needed "Good Press" for our cause.

"Dr. Gary Aguilar.....cited evidence that the wounds that killed one of America's most popular Presidents could not have been fired by a lone gunman."

"Aguilar called it "Extremely unlikely" the so-called "Magic Bullet" could have actually hit both Kennedy and Connally from a trajectory aligning with Oswald's perch, and has similar skepticism concerning the head shot that killed Kennedy."

"The physician said it is more likely that from four to six shots were actually fired from different locations around Dealey Plaza, and that the fatal head shot may have been fired from in front of Kennedy's limousine rather than from above and behind."

"The media," Jim DiEugenio said, "readily accepted information channeled to it from the intelligence community immediately after the assassination and has failed seriously to investigate the president's murder ever since." He castigated the press for failing to report recently released pieces of evidence in the case, including the fact that Oswald had solid associations with both the CIA and FBI, and that a shell casing was found in Dealey Plaza the day of the shooting that didn't match ammunition from Oswald's gun. "These are the kind of things the news media says are irrelevant. The Media will tell you there isn't anything new."

"Assassination expert, Dennis Lee Effle, also finds it difficult to believe Oswald could have hit Kennedy using a rifle with a telescopic sight experts later determined was misaligned. Effle said it's up to the public at large to insist the truth of the case be aired." "It's up to us," Effle said, "They're not going to wake up tomorrow and decide to come clean."
