To Prospective Member of CTKA:

As you can see from the package we have assembled, "Citizens For Truth About the Kennedy Assassination" is serious about doing something about the three major political assassinations of the 1960's: John F. Kennedy, Robert F. Kennedy and Martin Luther King.

Considering the initial responses to our group's formation, we, as well as many others, feel that the time for discussion is over and the time to take action is now! Fortunately, the election of the Clinton/Gore ticket and the appointment of the JFK review board creates an opportunity that none of us can afford to let pass by.

CTKA is not another research group. And our newsletter, "PROBE," is not just another collection of research articles and book reviews. Our group is a grass-roots political movement and our newsletter is a monthly report of what is currently happening in these cases. We plan to accomplish two major goals: the re-opening of the JFK case through the review board and the expansion of the scope of this review board to encompass both the RFK and MLK cases as well.

To accomplish these goals we first had to form an umbrella group under which others—both within the research community and in progressive groups outside of it—could work towards a common purpose. So CTKA was born.

We need YOU to contribute what you can. Fill out the accompanying forms so we can call on you for your support and your input. Together we can make a difference. This movement has to be broad-based, and nationwide if it is to be taken seriously by both the politicians and the media.

Some of the tactics we will use to implement these goals are: The organizing of a CTKA speakers' bureau; the setting up of a BBS (computer bulletin board); lending assistance to all major JFK conferences in obtaining maximum "positive" media exposure; the establishment of both regional offices and local affiliates; and the coordinating of lobbying efforts centered on Washington DC.

We can't do this without your help. We are at a critical stage of our development and need as many volunteers, activist and donors as possible. We owe it to our country, but most of all to ourselves, to try—perhaps for the final time—to recapture what was taken from us.

NATIONAL BOARD OF DIRECTORS

DR. GARY AGUILAR, Hillsborough, California. A distinguished member of the AMA, both as a practitioner and a teacher, Dr. Aguilar's articles on the Kennedy case have been published in J.A.M.A.

DOUG CARLSON, Hammond, Indiana. A public relations expert and social activist, Mr. Carlson organized the two "Midwest Symposiums on Assassinations," which have set the standard in this field.

KATHLEEN CUNNINGHAM, Ocala, Florida. A private businesswoman and former Republican political fund-raiser, Ms. Cunningham has become an expert on the medical aspect of the JFK case.

GAETON FONZI, North Bay Village, Florida. A former investigator for both the Schweiker/Hart sub-committee and the HSCA, Mr. Fonzi book about those experiences, "The Last Investigation," is due out soon.

JIM MARRS, Springtown, Texas. A veteran journalist and college professor, Mr. Marrs' book, "Crossfire," was one of the two primary sources for Oliver Stone's "JFK."

DR. DAVID MANTIK, Rancho Mirage, California. Both a physician and a physicist, Dr. Mantik is an expert on both the medical and ballistic evidence in the case. He is one of the few critics granted access to the autopsy evidence.

EDWIN LOPEZ SOTO, Esq., Rochester, New York. A former researcher for the HSCA, attorney Lopez is one of the authors of the famous "Mexico City Report," which was recently declassified.

WAYNE SMITH, Washington DC. A diplomat and former Cuban consular in the State Department during President Carter's administration, Dr. Smith has now completed his book, "The Kennedy Assassination And The Failure of The Fourth Estate," on the media's reaction to that event.

WILLIAM TURNER, San Raphael, California. A former FBI agent, and now a private investigator, Mr. Turner has written many books on a wide variety of national security issues; including the assassinations of both John and Robert Kennedy.

DR. CYRIL WECHT, Pittsburgh, Pennsylvania. Both an attorney and a physician, Dr. Wecht is a leading forensic pathologist published in many professional journals and has now completed his book on the JFK case titled "Cause of Death: The Final Diagnosis."

JACK WHITE, Fort Worth, Texas. A photo analyst for the HSCA and consultant for the BBC's 1988 program, "The Men Who Shot Kennedy," Mr. White's continuing work has been the basis for two recent video's on the JFK case.
