I am writing to select publishers, book dealers, computer product manufacturers, video and audio cassette duplicators, and periodical publishers who might wish to display items relating to political assassinations during our upcoming Three Decades of Doubt national conference from October 7-10 this year.

Due to media focus on the "cottage industry" aspect of our research work, we want to present instead serious and informative research items and tools, current computer technology and publications that reflect the best of our current work. The conference co-chairs, John Newman and Daniel S. Alcorn will be reviewing potential vendors and materials for approval.

We will create a special room for vendors, open to accommodate the conference schedules. A special space, and one or more display tables with chairs can be reserved for your items. Cost is \$100 for each whole table (6'x30"), and includes a 1/8 page ad in our special Conference Booklet, which will be distributed to hundreds of conference registrants, and other interested people. For a larger ad, each 1/8 page increment is available for an additional \$25, or \$200 total for a full page. Additional tables are \$75 each, and can be split by smaller groups.

Publishers may want to arrange for authors present to provide signed copies of their works. Computer product marketers may want to bring equipment to demonstrate their products. Audio and video taping of the conference will be limited to pre-arranged groups who will make tapes available to participants for the benefit of the Coalition. Vendors will be subject to D.C. sales taxes, and forms will be available.
