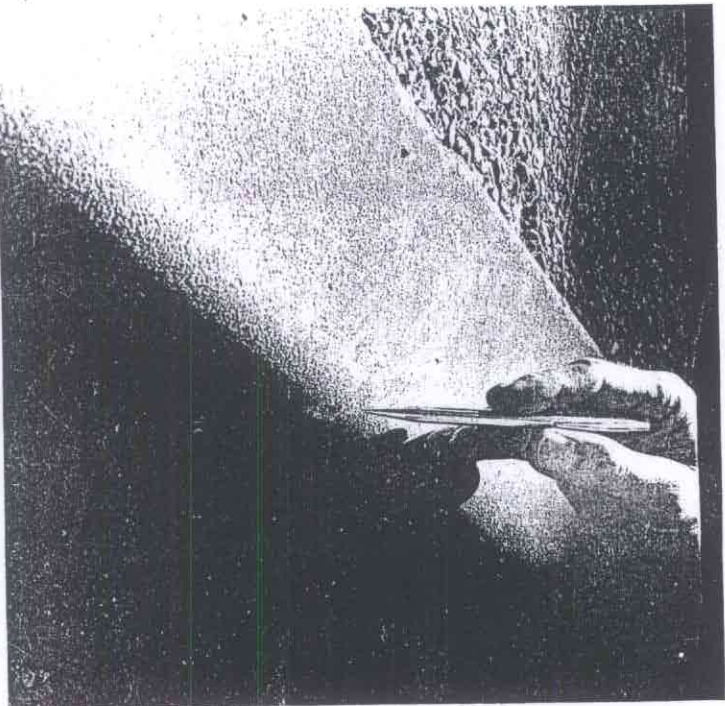
Revell encountered the FBI agent who can, from the unredacted initials on the memo, only have been Charles T. Brown, Jr., who lived at 916 Beechwood Drive in Richardson, a Dallas suburb, and whose phone number was AD5-3016. Revell also told him that Curry had told Revell "that two men were involved in the shooting," [Brown's words]. One of Curry's reasons was something he had been told by his police motorcycle escort of JFK.

So, contrary to the slurs from the depths of their ignorance by JAMA's cabal and equally uniformed Commission apologists as well as the not entirely uniformed staffers who protest their purity and performance when prodded a bit, there are those, other than the critics, who agree with the critics. Actually, it is the other way around. The critics agree with them, like Russell and Curry, who knew before the critics could.

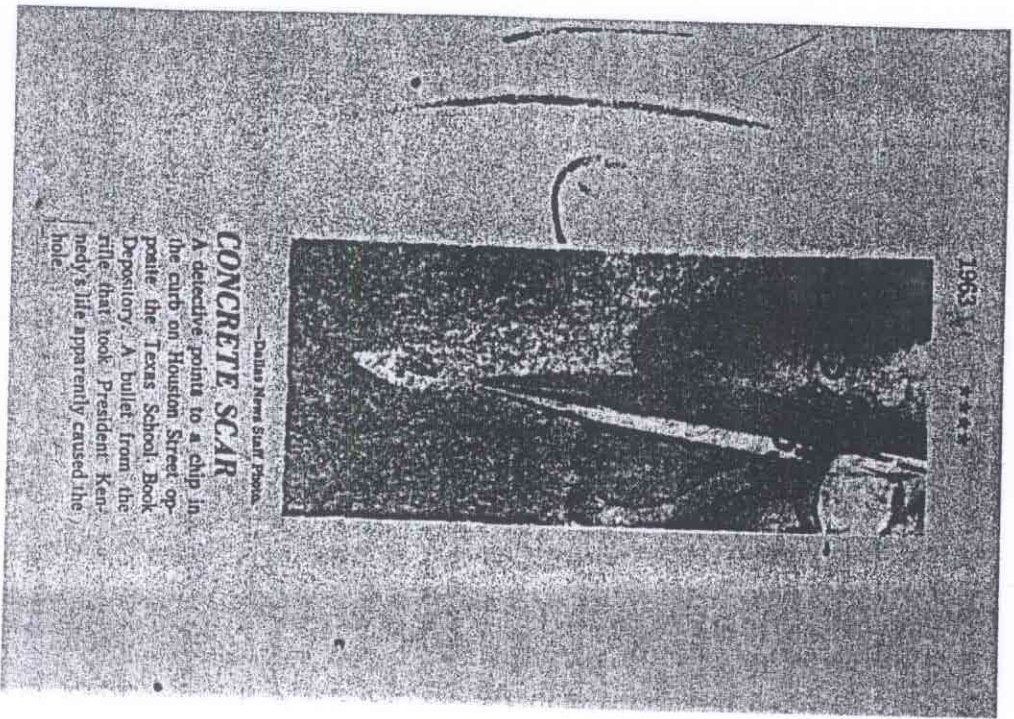
The best known of these other shots is the one the Commission acknowledged missed the motorcade entirely, the one that rushed the gestation of Specter's bastard. Although it was known and reported in the papers, the Commission ignored it, as the FBI and Secret Service still do. Tom Dillard, the *Dallas Morning News* photographer, had photographed it the day after the assassination and had told the local United States attorney, Barefoot Sanders about it. (A longer account appears in *Post Mortem* beginning on page 453. Dillard's photo is on page 609.) Oddly Sanders had said nothing about this when the picture appeared in the paper on November 24 and was on TV the night before. The FBI did not report it either. Dillard gave me a Xerox of the file Xerox in the paper's morgue. The caption says the bullet caused a "hole." (2-2-84 3:37)

He also printed and gave me a copy of his best remaining negative, those he referred to as the "federal's" not having returned the ones they "borrowed."

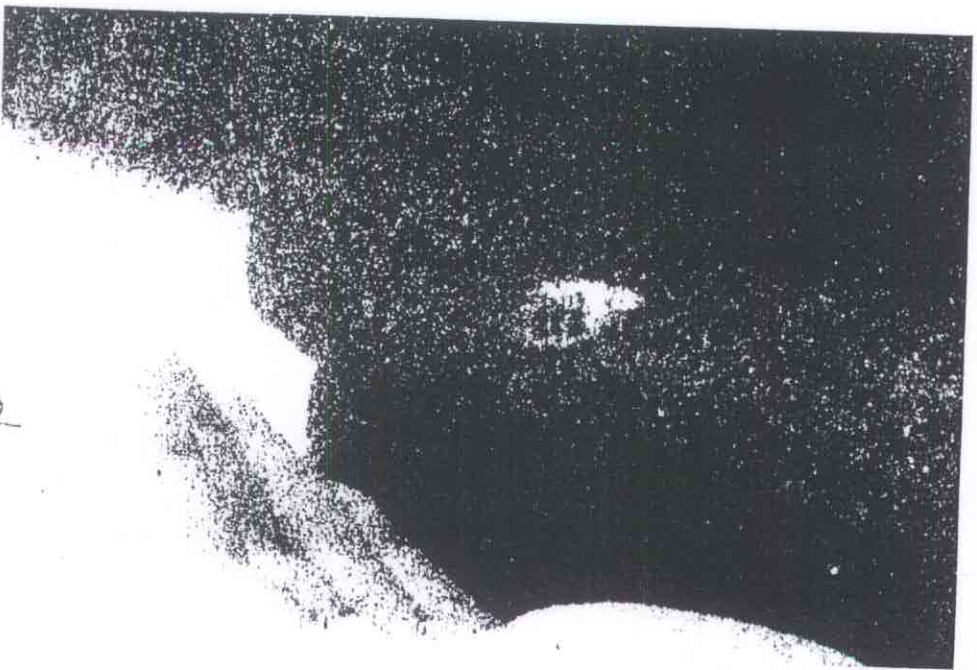
The spray of concrete from this "hole" in the curbstone on the south side of Main Street about twenty feet east of the Triple Under-
