The field crawls with those who seek instant fame and importance, lack the most elemental competence for this kind of work, and steal and embellish. So, from painful experience, I don't let anything out now except to a few of the most trusted. However, there is quite a story in this not even indicated in the new book. If you ever get time to come up I have no reluctance in trusting you. I can't take time to wifte a couple of rough drafts of books in explanation, though!

Matter of fact, I've had a book that should break the whole thing wide open camera ready for years and lack the money to print. All it needs is knowledge of how much

has to be cut from the appendix and the typing of the index already on cards.

Aside from assassin identifications there are fewer secrets than the blabbing of the well-intended (mostly but not entirely) who don't and can't do real work would lead you to believe. What is needed is getting it out.

We, too, are sorry about the Ray decision. It will mean an enormous amount of added work, mostly for Jim Lesar. But in the long run the cause of justice may be better

served by this monstrous and entirely unjudicial decision.
