The Great Debate put Lee Harvey Oswald up against Carlos Bringuier, the Cuban exile who had staged the public confrontation with Oswald ten days earlier; Ed Butler, anti-communist propagandist with the Information Council of the Americas (INCA); and the two moderators from WDSU-News, Bill Stuckey and Bill Statter.

Stuckey and Butler opened the debate by producing newspaper clippings that exposed Oswald's 1959 attempt to renounce his American citizenship and become a Soviet citizen. Lee Oswald prevaricated when he denied those attempts.
