You should then be able to have them mailed to you when they are provided to Marks and me. Tell him you want all that is located released on the subject, in the broadest sense, or if you do not fear contamination, which is possible with me and the CIA, I can ask for a duplicate set texame mailed directly to you. However, I think you could be satisfied with correspondence that they would send copies to you promptly.

If would be good to get together. However, I am not able to drive to Rockville now, close as it is. I suffered acute thrombophlebitis in both legs and thighs a little less than two years ago and some new probelms have developed. I see a specialist Monday. If you could come here, fine. It is about a half-hour from the Rockville exit on I270. We are a little over three miles, about seven minutes from the most convenient exit of the same read. (AT Frederick the numbering changes.) Our phone is 301/473-8186.

I besieve you have heard from Mike Conklin. I provide him with all I receive. He has time to go over them now, I do not. He can provide you with a quick guide to these pages. As I recall it he told me there are about a thousand pages of some kind of technical date in this release.

If I have never explained my initial interest in this subject it comes from having obtained evidence of Warren Commission interest in it and a couple of previously-withheld records. Then when the Olson story came out - I knew his son Eric when he was a fine kid in high school and a good photographer. Years ago I helped a couple of his school friends with a science-fair project on imprinting. The kids did it, too. As I had earlier, before knowing of Lorenz.
