I remember your call. You'll be welcome whenever you get here. If I did not tell you when we spoke, I live convoluted hours that require my retiring early, now about 4:30 in the afternoon. I'm up rather early, too.

From what you say the files I got under FOIA that may be of interest to you are on The Invaders and The Sanitation Strike. I have those of FBI Headquarters and of the Pemphis field office. The fact is that Hood College made copies of them for a student who was doing an honows paper and thereafter her professor and my good friend, Dr. Gerald licknight, made use of them. he will have a fiarly good recollection of them as I do not. And, at "ood, you can use the files and the copier almost side by side and not have the stairs in between.

On the other files, I think what will interest wis scattered and volume alone will be a serious problem. There are about 80,000 pages in all.

I suggest you write licknight at Good, 401 Rosemont Ave., Frederick 21701. His phone there is 696-3720. He is in and out of his office. He has office hours for students to see him Mondays and Wednesdays 1 to 2, Tuesdays and Thursday 10 to 11. His home phone, both area 301, is 473-5639.

The files on individuals are beyond imagining. I recall one small report of which so many copies were made the second page alone was a list of them. These are FBI files. You ask about the political campaigns? Congressman Ford's first was covered and that year so were city council meetings.

It is not easy to find a less depednable source than Melanson, believe me!

In the NURKIH files the FEI had some police domestic intelligence reports.

I think Arkin provided them. There is at least one longer report by him.

In the MURKIN files there also is reflection of official efforts at retaliation against invaders, strike sympathizers and their families. McKnight will remember better than i efforts against precachers.

There may be other ways you can get some of what Chandler ordered destroyed. Other agencies may have copies and the FBI may have some filed other than Rhom when I requested searches be made. Your own stories may reflect the widespread distribution made by the FBI. Again, McKnight will remember better than I.

There was a long list if existing files given to the DJ for its investigation of how Dr, King was treated. The Office of Professional Pesponsibility had that list and examined and made copies of some of them. Jim Lesar, who was my FOIA lawyer, filed that request when I was not in good shape.
