Colonel outlines 'historic threa

campus bomber 'cannon fodder



COL ROBERTS attacks world conquest plan.

CHARGING THAT THE CONSTITUTIONAL RIGHTS OF THE STATES HAVE BEEN PHASED OUT IN KEY AREAS AND RE-ESTABLISHED IN THE UNITED NATIONS OR A WORLD GOVERNMENT, LT. COL. ARCH E. ROBERTS, SPEAKING IN EAU CLAIRE LAST NIGHT FOR THE WISCONSIN LEGISLATIVE AND RESEARCH COMMITTEE, OUTLINED AN HISTORIC THREAT WHICH SURPASSES THAT OF A COMMUNIST TAKEOVER OF THE COUNTRY.

COL. ROBERTS STATED THAT THE PEOPLE OF THE STATE OF WISCONSIN SHOULD ASK THAT THEIR LEGISLATORS INVESTIGATE THE POSSIBILITY THAT SPECIFIC AMENDMENTS TO THE CONSTITUTION AND ARTICLES OF THE UN CHARTER ACTUALLY CRIPPLE THE CONSTITUTION OF THE UNITED STATES, THE STATE OF WISCONSIN, AND AFFECT THE LAWS OF THE STATE.

HE DECLARED THAT the legislators have sworn to uphold the state's constitution as they took office and have a duty to at least hear the evidence as Roberts and his Colorado-based Committee to Restore the Constitution.

Col. Roberts announced that he will meet in December with 25 to 30 state legislators to prepare a possible presentation of evidence to a joint session of the state legislature. Roberts has presented similar cases to State committees in Massachusetts, Kansas and Minnesota and has addressed the joint sessions of the Alabama and Mississippi State legislatures.

Roberts told the Eau Claire gathering, his sixth such meeting in Wisconsin, that we are engaged in revolution now, but rather than direct our anger toward the campus bombers and police-killers in our cities, who are but the "cannon fodder for the revolution", we should look deeper to seek out the financing and inspiration of the revolution.

"WE MUST SEEK OUT the control mechanism of the revolution," said Roberts, "and if we dare to look, we will see that this control lies in a highly placed group of intellectuals and industrialists."

Roberts charged that in 1966 the Ford Foundation poured \$500 million into over 1,000 revolutionary groups in the US. These groups, he went on, have since spread to every aspect of American operations, even to the extent of threatening to close our campuses.

"The revolution did not start two, three or even 10 years ago," said Roberts, "We must look to the year 1905 or thereabouts."

AT THIS POINT Roberts went into a step by step, historic account of a long range plan to weaken the US constitution, to level American Society and to erect on its ruin a new world government.

"Early in this century," Roberts charged, "an elite group of international bankers and industrialists formulated a three prong attack which would eventually bring the world and its economic resources into their hands."

"The techniques which they elected to use were infiltration, subversion and eventually revolution to remove the constitution of the US and impose a quasi-legal apparatus upon the people of the world."

Roberts pointed out that in order to implement these techniques, the planners had to gradually change the spiritual and intellectual climate of the country.

First the group had to get control of the universities through its professors. The professors could change the thinking in future teachers and eventually students of every phase of education, and ultimately control, financially and intellectually, the mass media, industry and the culture of the nation.

"AS THE DOCTRINE of world government spread through our universities," said Roberts, "and its students were lead to believe that a world government would be controlled by an intellectual elite for the good of humanity, all aspects of our economy were redirected from American ideals to a concept of revolution."

The second phase of implementation, Roberts pointed out, was the spiritual control of the population. Up until this plan was

launched, the spiritual strength of America lie in its churches, now, Roberts went on, "by infiltrating the churches the conspirators have warped the soul of America and have created a permissiveness in all aspects of society, a permissiveness which does not violently reject evil, but accepts it as part of nature and actually reject the good."

"WE ARE TOLD," Roberts noted, "that permissiveness is necessary for an advanced culture, but in the meantime that concept is destroying the fiber of the nation."

Roberts said that America has become characterless because we have permitted our churches to become infiltrated with the idea of the brotherhood of man, one church and the creation of a god-man which supercedes the power of Jesus Christ.

"Having gained control of these two elements of influence on our society," Roberts went on, "the apparatus was complete, but to obtain all objectives, it was necessary to gain control of the government."

To accomplish this, Roberts charged that in 1912 the internationalists set out to install an agent in the US presidency. In the election of 1912, Roberts noted, two parties ran candidates, but in order to split the vote of the GOP party, the Bull Moose Party was created "out of nothing". In this way the Democratic candidate was elected, and Woodrow Wilson became the first agent of the infiltration to occupy the highest political office in the land.

To prove his point, Roberts indicated that within a year, three measures were established as part of American law which were designed to create a power bloc or basis for the completion of the take-over plan.

The first step, Roberts charged, was the creation of the 16th amendment to the constitution, the creation of the income tax. Once this was unwittingly accepted by the states, the government and the infiltrators, had unlimited access to working capital and had the authority to tax and destroy those who would seek to upset the economic take-over.

THE SECOND STEP was the 17th amendment which took the power of control over the federal government which the states retained with the constitution. In this amendment the two state senators, which were originally planned to voice the opinion of their state in federal government, were slated for election by popular vote. This, Roberts pointed out, deprived the states of power in controlling the workings of the federal government and also limited the effectiveness of the senators to represent the people. Roberts stated that a senator can be elected once by popular support, but in re-election he has to call upon the backing of the mass media and high finance to wage an effective campaign. Once he is compromised in this manner, his loyalty to his constituents is questionable.

The third step was the creation of the Federal Reserve, Roberts pointed out. This aspect of the government deprives the congress of its constitutional right to regulate and coin money and gives it to 12 international banking concerns called the Federal Reserve Banks.

Roberts charged that the Federal Reserve now has the power to control interest rates, the stock market, the circulation of money

and by withdrawing capital, can create a depression. He noted that the financial crash in the 1920s and '30s was designed to kill the last independent banks and finalize the implementation of the federal reserve.

THE FINAL PHASE of the takeover of the world by the international bankers, is the establishment of a world government. He stated that the Wilson government attempted to submit such a plan in the wake of the First World War, with peace and international security as the selling point.

THIS WAS NOT ACCEPTED by the Senate, Roberts pointed out but was reintroduced again after the Second World War, to a new generation as the UN Charter. Roberts noted evidence that the UN did not emerge spontaneously from the 1945 meeting in San Francisco, but in reality was discussed in the State Department, two weeks after Pearl Harbor.

Roberts charged that the creation of the UN has taken away the power of congress to declare war, control nuclear weapons and raise an army. The UN now has control of these operations, Roberts charged.

To put a halt to this takeover of the US constitution, Roberts called for citizen support of state legislators who will investigate the effects of the UN Charter on our constitution, the state constitution and our state laws. He noted that work is being done to create a voter network and meet with the state legislature for action against the alleged world takeover.

Roberts, in answer to questioning, stated that communism is but a successful revolution also inspired and engineered by the same group of international bankers. He stated that too much time is being wasted chasing down communists when the real threat to the nation is ignored.

Roberts cited the Council on Foreign Relations as one of the most powerful groups implementing the plans of world government. He charged that our current federal administration, including the president, includes 80 members of the Council.

HE STATED THAT THE Vietnam pullout is being effected now because a world government inspired industrial complex has been successfully set up in South Vietnam and the American people are being conditioned to accept a UN commitment of American troops in a war in the Mideast.

Roberts further charged that the current uproar in the nation over student bussing to end segregation is but a Supreme Court interpretation of UN General Assembly resolution 1904 which calls for an end to all forms of discrimination in the world.

In conclusion, Roberts emphasized the need to work through legal means to re-establish the constitutional control which the states have had over the federal government.

RESOLUTION NO. 1

COMMITTEE TO RESTORE THE CONSTITUTION

A RESOLUTION DECLARING THAT THE PEOPLE OF THIS STATE SHOULD DEBATE THE QUESTION OF WHETHER OR NOT ANY AGENCY OR INSTRUMENTALITY OF GOVERNMENT WHICH DERIVES ITS POWERS FROM THE CONSENT OF THE GOVERNED CAN VOLUNTARILY, BY TREATY OR OTHERWISE, ALIENATE THE POLITICAL SOVEREIGNTY OF A FREE PEOPLE.

WHEREAS, Federal Agencies, by treaty and other acts, allege the transfer of vast powers of government from the Congress of the United States to international agencies in violation of the prohibitions of the Constitution and without the knowledge or consent of the State or the People, and

WHEREAS, a compliant Congress permits the commitment of America's soldier sons to international military adventures "with neither promise nor hope of Victory"; and

WHEREAS, the actions of Federal agents exhibit a contempt for the limited delegated powers enumerated in the United States Constitution, which is very explicit about the authority for making war and keeping peace; and

WHEREAS, American citizens, acting through their State Legislature, are morally and legally obligated to do whatever may be necessary to insure that all provisions of the Constitution of the United States shall be respected and enforced, be it therefore

RESOLVED that _____, COMMITTEE TO RESTORE THE CONSTITUTION, does hereby call for an investigation of the actions of Federal agents with regard to United Nations agreements and other ultra vires acts and demands enforcement of the Constitution of the United States in relation thereto.

To implement these objectives, _____, COMMITTEE TO RESTORE THE CONSTITUTION submits to the Legislators of the sovereign State of _____, in accord with the oath to which these officeholders subscribed upon accepting position of public trust ("to support this Constitution") and in consonance with the obligations of the parties to the Constitutional compact ("to insure that all provisions of the Constitution are respected and enforced within the boundaries of the State"), the following proposals and demands:

1. That the _____ State Legislature investigate the actions of certain Federal agents who have purported to negotiate with foreign governments to coerce the State into agreements which would surrender to foreign governments the rights and liberties assured to the People under the Constitution of the United States, and

Which would surrender the powers of government which this Constitution guarantees to preserve to our People, and

Which would transfer citizens of the State of _____ now serving in the United States military establishment to a United Nations army in the name of "international peace and security."

2. That the _____ State Legislature promulgate and enact appropriate statutes which will provide for enforcement of the Constitution of the United States with regard to the United Nations Charter and other ultra vires acts within the boundaries of the State of _____

3. That such deliberations, decisions and statutory enactments by the _____ State Legislature shall be disseminated in compliance with Section 1, Article IV, and shall respect the provisions of Section 2 and Section 4, Article IV, of the United States Constitution.
