They accounted for only 3/4 of the so-called King (really Ray) volumes they had published some time ago, they do not account for a third category, administrative and legislative, and I understand that the relatively small printing order included a set for each Members.

There is to be one additional "King" volume; making a total of 13. The entire set is to be 27.

If you should obtain a set, please do not reserve them for me. And effort I made months before asking your help materialized and I do not need them. However, because they begin scarce they will become valuable. For me they hold only negative values, aside from the completeness of the archive I will leave.

Do not misread my not having been by to say "hello." I never go to Washington any more except for madical or legal purposes. My health has deteriorated, it is unvise for me to drive that distance, little as it is, so I concentrate on trying to force the mountain to labor. So far it has birthed more than a mouse. And I have it laboring still.

But at the same time it enables them to keep me so tied up I can't find time to put it all together.

If you ever get near here I'd like to show you some of it. You won't find/in the folumes you could not get.
