Editor:

Don Ecker's two-part series about Bill Cooper, contrary to Cooper's habitual and phony threats to sue, was restrained and to the point. A number of damaging charges, in fact, were understated in the articles or were withheld entirely from print.

The many opportunities Cooper has been given to present proof or evidence in the face of reasonable questions—all ignored—only add to the overwhelming presumption that his refusal to deliver actually represents an *inability* to deliver. And that brings into question his entire story (excepting that portion he lifted from others that may have basis in fact), which may exist only in his imagination as a scheme to extract money from gullible audiences.

I have interviewed a former Navy Lieutenant Commander who did actually serve on the CINCPACFLT intelligence briefing team, starting one year before Cooper's tour of duty with the Flag Administrative Unit in Honolulu and lasting one year after Cooper was shipped out to sea duty again. This officer told me that

he does not remember Cooper at any briefing, and says he believes the story is simply a hoax.

If the national security apparatus of the United States continues to exhibit marked disinterest or total disdain in Cooper's "courageous" efforts to present government secrets to the public, a prudent person might conclude there is simply no basis on which the government might prosecute him. It would seem any prosecution would be at the state level, where he might be tried for fraudulently taking money from the public; however, the great success of P.T. Barnum illustrates just how likely that would be.

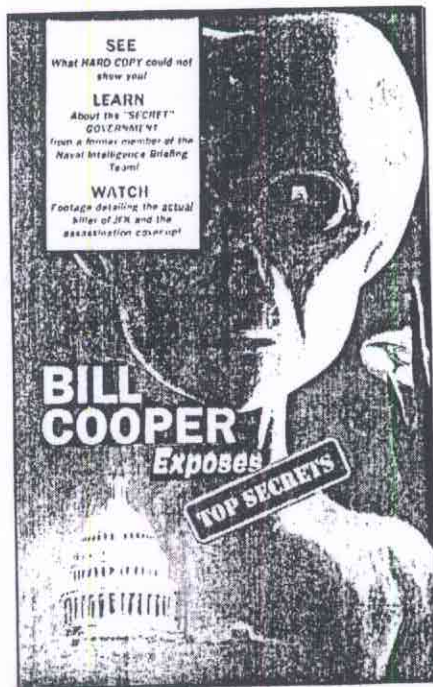
