5/5/72 Jim: You have been all out for so long I presume you may be able to find a bit of time for a little work in the library. It is not work I am at all confident will have meaning but it is so obvious I think it should not be ignored and I don't know anyone else who can do it so I ask it of you, with this brief explanation. I don't have to tell you the consequences of what Wecht has done. There was some turmoil before it because everyone disagreed with me on its inevitable consequences, for an assortment of reasons involving judgement, refusal to think, frustration and other things. Something like it was inevitable once officials decided upon it, but wecht was the worst from our point of view, some, for example, then Nichols. Anyway, although everything was inevitable except our capacity to do something about it, which was fractured away, the whole thing has an interesting origin. Without this origin it would still have happened, but the fact is there is an identifiable beginning. GWS sent one Ned Crosby to me. We accepted him at first on GWS' word. We'd later have accepted him on his own, so for this GWS can't be faulted. However, only after this led to great pain and the waste of an enormous amount of time for my wife and me did GWS confess knowing in advance that at best Ned was unstable, with serious emotional problems setting to work for a guilt feeling, having inherited enormous wealth (General Mills, Meyerkauser, etc.) GWS then also confessed that Ned was guilty of unconscionable acts. As I remember the story it is that GWS learned Ned was going to a shrink. This shrink had a woman patient. He started lying her. When Ned was warned about this shrink's ethics, he told the husband, with consequences you can imagine, including for the patient. One way to help the sick, well, Ned and I made a deal the particulars of which are not except in one respect immediately in point: he would make no use of anything I gave him without my permission and would speak to no body involved without it. He was going to condense PK for commercial possibility and pay for the appearance of the full thing in underground form. He broke every part of the entire deal. He knows Katzenbach. He took particular offense at a chapter which shows the deliberateness with which exculpation for those really responsible for the real suppressions was contrived and how it was pinned instead on the uninvolved Kennedys, who had nothing to do with the investigation. This chapter also shows the involvement of Katzenbach in the ploy. After breaking the deal and doing what he committed himself in advance not to, Ned started laying court to Burke Marshall, who had earlier agreed not to give anyone access. Knowing the potential and knowing enough to be absolutely certain of the improbability of anything new coming from this film, I saw to this through a Senator and I did get word back after he spoke to Marshall. Ned spouts Katzenbach because they are both on the board of an Africa-America institute. The world's least dependable authority in a different context says an institute of this approximate size is a CIA front. It is Joesten, in his 6/1 or 6/15 newsletter. So, what I'd like in the composition of all foundations of any variation of this kind, African(A) or American(A) front or inst. - it is how long lasted. It may mean nothing, but it is, I think, something we should know, and I ask that for the moment you keep this between the two of us, so as not to hurt anyone needlessly or to kill what might have to be revealed on.
