Dear Ned,

Were it not that I am expecting a visitor this afternoon and to almost 3 p.m. have been occupied with things that could no longer be postponed, I'd not now be writing this letter that has been on my mind for a while. I have completed the missing part of POST MORTEM and have begun to read and correct it in anticipation of the coming next week of a very bright young researcher who has made his own detailed study of the medical evidence. It had been my hope to be far enough ahead of him so that he'd have at least the typos corrected. I wrote these 75,000 words without a note, without reading one before going on to the next, to get the essence on paper. Without even consulting two large files I'd laid aside for it because mine is not the usual writer's problem of not having enough material. It is, rather, having too much. I have a number of special reasons for departing from my usual practise of reading each chapter as I finish it so my wife can retype at leisure, but I don't take time for more than saying I wanted to get the nitty-gritty on paper and thing I have-and subject to learning, I think it is far and away the hottest thing we have ever had that, if anything no one can, can accomplish what we all want. This is not to say "will".

I presume your visit with Weinrab turned out as I expected, having heard nothing from you or Gary about it. There is not much these guys can honestly do or say. Even the few honest ones had to have serious doubts.

My court "loss" in the suit for the clothing pictures turned out to be a larger victory than I'd expected after recognizing it was a victory. Again to abbreviate, it has led me to sensational new (photographic) evidence that cannot be refused me but might be, which would then lead to a court action I ought not be able to lose, for these are special versions of official exhibits and I have a written record, built up over the years, of official statements that say I must be able to get them. I have seen them, have notes, measurements, etc. and they are important in ways I've already solved and are in ways I haven't also, meaning that with the uncertain it is conjecture. In fact, I already had some. The difference is that the originals are in clear color and the black-and-whites almost meaningless. My problem is I don't have the upwards of \$72.00 for the six (and possibly more I've not yet found) at \$12.00 each. Free enterprise means profit on the assassination. This is for 8x10s only. In relevant areas I've new knowledge, too, which I ask that you keep entirely to yourself. This includes the destruction of official evidence more than I'd know and show you, and I have that is the most casual written proof. So, aside from wanting these pictures so I can have competent black and white prints of parts made for use in the book (I can't think of printing that blood if I or a not-likely publisher could bear the price of color) color is best for study and for consultation with medical experts of various kinds. One of the points is a blood-pattern entirely inconsistent with the official account. Radically so. If you can swing this for me, fine, but don't be embarrassed to say no. I'll be there again in 10 days to pick up what is being copied that my depleted account will cover and can then inquire into what else may be available. Or, perhaps it would be best to seek those I've seen first then seek others.

The clarity of the black and whites is not accidental but is designed to and does hide important knowledge visible in the color and in 10% of the testimony. "guilty knowledge."

If you and your family still intend to come before summer is over, as we hope, I can tell you then. Meanwhile, if you should read either of the PMS, I'd appreciate suggestions on cutting which in I in particular must be severe to limit 100% to what is medical or necessary for comprehension, such as the outlines, etc.

I wish I felt that publication looked likely, or that I had the means of a private printing, which in this case, for the first time, might have the possibility of turning Teddy and/or his friends on. It is more than that they cannot co-exist with. It is the closest thing he/they will ever have to a defense. When I have this all done, then I'll seek a way of letting one of them know. Let us know if you can make it. Hope this is going well.
