Dear Mr. Crouch:

Enclosed is the title page for Newcomb & Adams book, provided by Mary Ferrell, and finished in 1974. It contains the entire body theft and alteration theory. But what is more interesting, it contains a very major critique of the Zapruder film, pointing out many examples of forgery and missing frames, especially during the head of sequence. This puts the lie to Groden, and tells us why they had to launch him and control the film.

What would lead anyone to turn against someone who trusted them implicitly and set that person up for possible arrest and a lot of trouble? A misreading of that person's intentions? Jealousy and hatred? A secret criminal conspiracy?

I think we are in the middle of quite an operation right now. I'm fortunate to get some real help from law enforcement over the last year during this difficult time. Groden is in deep shit because he is up against a lawyer who was a prosecutor for years in New York. He is tougher than shit, but Groden doesn't see it coming.

We know that Groden had black & whites in 1978. Lifton says that he had a set of those, and we know from Fox's family that Fox did not have any photographs at that time or later. So what is going on here?

Obviously, the attempt had to be made by provoking me during the incidents last summer and fall, then at ASK, then with the boys at Christmas time, and two weeks ago in Dallas. The trouble is, people are trying to frame us, and trump up false charges on us! Now, you know that there are crimes involved in doing all that.

Mark, Mary Ferrell makes no long distance calls. Her phone records show no calls to you. There was one exception, and this is very rare with her. She made one long distance call only, and it was on March 8, to the Baltimore Police. This preceded your call to her that day when you told her that I knew everything that she was doing that morning. At no time previously did you have contact with her. Question, Mark, why would you call IA and try to get us into trouble for something we did not do? All of those charges were manufactured. Why? Do you think Groden's promises mean anything, if

he wins his suit? (He won't. There will be no settlement, ever, either. The publisher and myself are absolutely firm on that.)

I am still waiting for your phone records and the police affidavit from the State policeman. Or at least give me his name. There are very serious charges against you. Your only hope of staying out of trouble with all of this is me.

I took very seriously the charges you made against me in Operation FIREHELL. We knew you wrote it at the time, and that gave me a window into your soul. Your crazy explanation of not being able to tell us that we were being investigated and so you wrote the FAX in order to telegraph what was happening to you doesn't wash. It tells me what you think of me and how you tried to trick me the last three years.

Well, Mark, we know that you are the one trying to make trouble for us with the BCPD. *It is you and only you.* Why? What's in it for you? Don't you think we know everything that is going on? Don't you think this is all an elaborate trap and the double bind? All of those statements are completely false, and when you do that, you engage in not only a criminal conspiracy, but the crime of making false statements to authorities. No wonder you are preparing to flee. I hope you take your family with you and not abandon them.

We're digging out some of the biggest stories of this century, and I am sorry to see you caught up on the wrong side of it, *used*, and they will throw you away when they have used you up, *because you are disposable*. This is an FBI operation, and do you think it will get you anywhere to curry favor with them, with Groden and his gang? Everybody will just throw you away, including me.

Well, we've dug it out, and if you have persisted and tried with one more huff and puff to blow us over with false charges, or just to make trouble and slow us down, hoping we will somehow be stopped, you have another thing coming, because it won't happen. You never understood where I am coming from and all those who are behind me.

It was you who tried something so despicable last Christmas that from that moment on you became a major target. It was you that made false statements to law enforcement about me and the boys. It was you who accused me of orchestrating what you know that you and Groden did to me.

It isn't going to work. Groden and his gang are all through now. We know the whole story, in Washington and Dallas with him, and the game is over. Forever, and legally too.
