## AFFIDAVIT

- I, Kenneth A. Jacobsen, being duly sworn, depose and say as follows:
- (1) I am a Special Agent of the Federal Bureau of Investigation (FBI), assigned to the Los Angeles Field Office of the FBI at Los Angeles, California. My responsibilities as a Special Agent include the handling of Freedom of Information Act\* (FOIA) matters within the Los Angeles Field Office.
- (FBIHQ), received on August 10, 1977, I caused a search to be made of the General Indices of the Los Angeles Field Office, on August 10, 1977, for all records and exhibits pertaining to the assassination of Dr. Martin Luther King, Jr., and filed under the FBI designated title for that investigation, "MURKIN." The method of search conducted was the same as that utilized to retrieve records necessary to fulfill the FBI's investigative responsibilities.
- (3) Thereafter I supervised the review of those records and exhibits located pursuant to the search described in Paragraph (2) above and, on August 22, 1977, forwarded one copy each of said records and exhibits containing documents to FBIHQ, with the exception of those records previously directed
