I read you chatty, long p.s as soon as I got the mail, then put the tape on and was interrupted five times while listenong to it, four times by the phone and once by our medical insurance representative.

Getting burned by selfescekers and the self-important is not at all unusual. Nor is being deceived and misled and lied to. There are all kinds of people in all walks of life and we have our share. Idll get to this in abbreviated form soon.

My own belief is that nothing new and significant is likely to surface on the RFK case except possibly through examination of the stuff in Sacramento and plenty of people are doing that. I think if you try to develop anything new it will lead to frustration and futility. I don't know t e condition of your files bub if you want them to be of use to others you might spend time organizing them. I don't know wht Phil Melanson hasn't answered you but he has a fill-time teaching job, has his archive to work wowd on and I think he is writing a book on the King case. He didn't tell me this but I think I heard it.

You regard some people as dependable and I think they are not. Of these I mention only Morrow. He is a fraud. He makes it all up, particularly "Getrayal." I knew he made it all up when I read the second paragraph. I liad it aside when I finished the second chapter.

He is, I understand, a convicred forger. When Betrayal was out I agreed to debate him on a radio station, by phone. He'd agreed and when he learned he was to have me on the other phone he enacelled. There is so much of this! And most people are not able to detect it.

Then there are those to whom almost anyone else is some kind of agent. Take Penn Jones, for example. When I saved Jim Garrison for a terrible mistake that would have been very hurtful, Penn immediately started calling me a CIA agent. It is is irresponsibles who elimin to their need for agents. These kind do their work. They don't need others and don't have to do it for themselves. Alas, it is this way. Penn was himself pretty wild abd with the bes of intentions knewhlaunched many fictions as fact. I've not heard from him in years. Last I heard he had moved and sayn't interested any more. Living with a younger woman. No question in my mind about his intentions but he was paranoid when I first met him and he got worse.

In the end May's situation may be better than it was because with his earlier experience he should be more valuable in management as he learns more about management. I hope so for both of you!

It is now 4 p.m., I've been up 12 hours and succept for r ading the morning papers and my walking therapy I've been able to do nothing that I'd planned today. Thanks for your good wishes. I go back to the hospital for the next check 1/12. I m hoping they then take the stitch(es) out and prescribe new glasses! Reading this type strains me too much on the poorer eye and it is fizzy in the corrected eye, may be for a while yet from what others tell me.

Fensterwald is not an agent, by the way. I know him well and I've seen copies in fact have copies of some of the CIA and FBI spying on him. This doe not mean that on many things I do not agree with him for I don't. I've never joined any of his organizations. I also don't subscribe to any of the newslett rs. A couple are sent as free. I'm not interested in gossip and too many of those people are utterly lost and don't have the slightest idea of what they are talking about. I have nothing against any of those putting them out abd rather like most but what they turn out does not inter at me and I don't want any one to think I as f avoring any others over them. Goota close but I want to say that we are all indebted to Ted for the recording he has done. If he hadn't done it most of it would never have been done. I think he just appeared yesterday or the day before with Garrison at a press conference on Jim's book. LIBRARY WHICH IS FILLED TO CAPACITY AND I CONTINUE TO TRY AND MAINTAIN IT, WHICH AS YOU KNOW IS EXPENSIVE BUT MOST IMPORTANT IF ONE WANTS TO WORK IN THIS FIELD, IT IS REALLY A NECCISITY TO CONTINUE DOING, EVERY ANNIVERSARY THERE ARE NEW AUTHORS THAT POP OUT FROM NOWHERE AS WELL AS RESEARCHERS AND INVESTIGATORS THAT WE ALL KNOW COMING OUT WITH NEW MATERIALS, IT IS AN ENDLESS TASK TRYING TO KEEP UP WITH IT ALL, BUT I FEEL IN ORDER TO BE OBJECTIVE, I MUST CONTINUE TO READ WHAT IS PUBLISHED. THAT IS SO EXPENSIVE FOR ME NOW THAT RAY HAS MOVED INTO MANAGEMENT DUE TO HIS BACK SURGERY, HE SUSTAINED A 53% PERMANENT INJURY TO HIS BACK AND CAN NO LONGER WORK AS A AIRCRAFT MECHANIC AND AS SUCH HE IS PAID NO OVERTIME, THERE ARE NO AUTOMATIC UNION INCREASES IN EARNINGS LIKE BEFORE SO HE IS MAKING HIS WAY UP THE ORGANIZATION, SO TO SPEAK. FOR THE PAST 14 YEARS SINCE I GOT INTO THIS WORK, EVERYTHING ELSE WITH THE EXCEPTION OF MY TWO BEAUTIFUL CHILDREN HAVE HAD TO TAKE A BACK SEAT TO WHAT PENN AND LILLIAN SAID I WAS MEANT TO DO FOR MY LIFE'S WORK, TO DEVOTE MY ENERGIES AND RESOURCES TO SEEING THAT THE TRUTH BE GIVEN TO THE AMERICAN PEOPLE. I SHOULD INCLUDE TED GANDOLFO AND MAE BRUSSEL WHO WERE ALWAYS VERY GENEROUS WITH ME AND I WITH THEM AS WELL. A GREAT DEAL OF WHAT I HEAR IS IN TED'S NEW BOOK THAT HE IS SELLING FOR \$22.00, I HAD OBTAINED FROM THROUGH REP. GONZALES OFFICE THROUGH THE GOOD AUSPICES OF HIS ASSISTANT GAIL BEAGLE. RULES COMMITTEE HEARINGS, ETC, THAT I HAD COPIED AND SENT TO TED.
