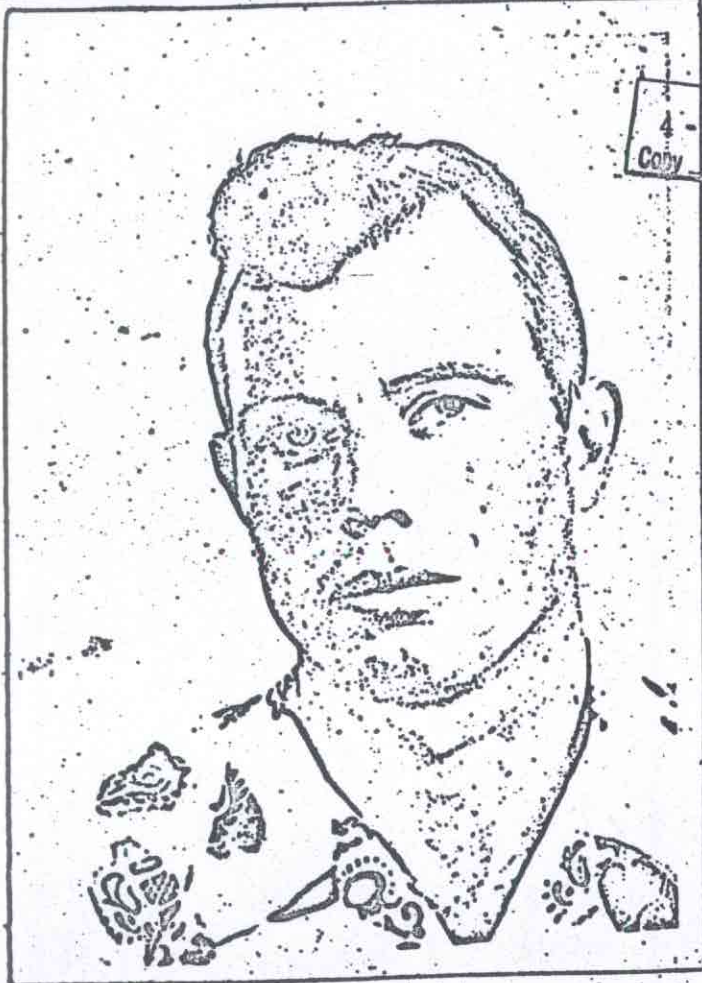

Sir:

At 12:31 P.M., November 22, 1963 the President Of The United States, John F. Kennedy, and Governor John Connally were shot by rifle fire on Elm Street, west of Houston Street. The President expired at Fairland Hospital at 1:00 P.M. Governor Connally was critically wounded.

At 1:18 P.M. a call came over the Police Radio, "Hallo, hallo, an officer has been shot at 400 East Tenth, and I think he is dead."

The officer was J. D. Tippit #248 who was taken to Methodist Hospital by Dudley-Hughes Ambulance and pronounced DOA at 1:25 P.M. He was shot in the right temple, right chest, and the center of his stomach approximately three inches above his waist line.

The murderer of Officer Tippit was arrested a short time later in the Texas Theater, 231 West Jefferson. He was subsequently proven to be the same man that assassinated the President and wounded Governor Connally.

Officer Tippit was assigned on District 78 but was pulled in closer into the area of the assassination to cover. The murder occurred on District 8A.

From the account of a witness, Officer Tippit stopped the suspect for interrogation, probably from a seagor physical description. His clothing had been changed. They spoke briefly through the right front window of the squad car. The suspect was talking. The officer got out of his car and started around its front to the suspect when the murderer started shooting. The officer fell by the left front fender of his car.

I recommend that a Police Cross be awarded to Officer J. D. Tippit who lost his life in the performance of his duty.

Subject: Injury Sustained while on
Duty

Sir:

On December 7, 1961, at 11:45 P.M., while working squad 89,
I received a radio call to Jefferson Blvd. east of Westmore-
land, regarding a disturbance.

While proceeding north on Hampton Rd. enroute to the call,
I observed two vehicles blocking the intersection of Hampton
and Jefferson Blvd. The occupants of these vehicles, five
white males, were fighting in the street. In quelling the
fight and the subsequent arrest, I was scratched on the left
side of the face by one of the participants. I do not know
which of the five persons made the scratches.

I contacted Sergeant Hugh F. Davis who admitted me to Park-
land Hospital, where I received a tetanus shot and was re-
leased to duty by Deeter V. Yoder.

Gentlemen:

The following is a medical report on the above named patient dated 8/13/60.

The patient states that he has been in excellent condition since his last examination in January, 1959 and that he has had no difficulty with his right leg. He states that on 8/12/60 while driving a patrol car he began having pain in his right leg involving the hip and the knee with difficulty in utilizing the brake and the accelerator. This gradually subsided then increased in pain to where he could hardly utilize his leg and he was brought to the office this date by his sergeant for evaluation.

Physical examination reveals some tenderness about the right hip with marked guarding of motion and loss of flexion and rotation. There is some tenderness about the right knee. X-rays of the right hip and pelvis are negative.

Diagnosis is synovitis, hip joint, right, acute, cause undetermined this date.

It is felt that this patient has an acute synovitis of the hip joint which maybe the result of prolonged sitting and car driving, however, it may be on an infectious basis or on the basis of calcific deposit developing in the hip joint. In view of this the patient is to refrain from work for one week, he has been placed on aristogestic drug for inflammatory process and drug for pain. He is to return immediately if he begins developing fever or if symptoms increase. Further indications await his return visit in a week.

Gentlemen:

The following is a progress report on the above named patient last seen by me in my office on 9/2/60.

The patient returns this date stating that he is gradually improving and has resumed work, however he has a slight amount of aching pain about the right trochanter during a tiring day. He is able to relieve this by local heat applications. Today the tenderness is markedly improved, he still has slight guarding of his right hip motion. He is to continue work, local heat as needed and return in six weeks for possible final evaluation. He is to return sooner for injection therapy if necessary.

Dear Mr. Roach:

The following is a copy of my record on the above named patient first seen by me in the office on 11/6/56.

Family history is essentially negative. The patient states that he had an abdominal distress about 2½ years ago and was treated at the Veterans Hospital without a definite diagnosis being established. He recovered and has had no difficulty since.

The patient states that about April, 1956 while on duty for the City of Dallas he and a fellow policeman were attempting to arrest a mentally ill patient when the patient stabbed him in the right knee with an ice pick. The patient reported to Parkland Hospital where emergency care was carried out but no x-ray made. The following day there was considerable swelling and the patient then returned to Parkland where further care was administered. Ace bandage was then applied and the patient states that after about three days the swelling seemed to subside. He limped for about two weeks after this, but then seemed to be doing quite well until about six weeks ago when he noticed that he developed pain in his right knee again. He noticed pain mainly after sitting for any length of time. The pain would seem to be in the region of the previous wound. His leg has felt weak since the injury but he thought that this would continue to improve. However, it has not and seems to be increasing in the amount of weakness over the past six weeks. He is referred to the office this date by the City of Dallas for evaluation.

Physical examination is essentially negative. The penetrating wound over the lateral aspect of the right knee is well healed. No loose bodies are felt and there does not appear to be any swelling of the knee this date. There is pain, however, on compression of the patella against the femur. AP and lateral views of the right knee reveals a metallic foreign body penetrating through the patella in the superior pole and approximately 1/4 to 3/8 inch of the sharp point of the metal is protruding into the articular surface between the patella and the femur. There does not appear to be any severe reaction about the metallic body this date. Diagnosis is (1) metallic foreign body, articular surface, patella and femur, right and (2) synovitis, knee joint, right, traumatic and secondary to #1.

It is recommended that this knee be explored and the metallic body removed and any degenerative cartilage removed as a result of wear and tear from the sharp point. This should be carried out as soon as possible and the patient is scheduled for November 16th unless the City of Dallas advises otherwise. Surgery is to be carried out at Methodist Hospital.

It is estimated that this patient will be off work approximately 3-4 weeks minimum and maximum about 3 months depending on the amount of damage that is found at the time of surgery. There will definitely be permanent disability to this knee in any event, but the sooner the surgery is carried out, the less the permanent damage.

While working district 104 April 28, 1956 we received a call at 8:28 P.M., to 752 N. Edgefield, regarding a demented person.

Upon our arrival at this location we contacted Mrs. Vicki Shaver, w/m/25, who was standing in front yard and stated that her husband had run her out of the house with an ice pick and threatened to kill her and commit suicide. She further stated that she wanted us to go into the house and get him out.

We went to the front door where the suspect, Robert Lee Shaver, w/m/25, was standing and creating a disturbance by talking loud and threatening his wife. We asked him to come outside and he refused.

We pulled the screen door open as he shut the wood door. We opened the door and as officer D. H. Smith and I went in, he stabbed officer Smith in the left shoulder with an ice pick and I was stabbed in the stomach and right knee.

Suspect was subdued and handcuffed and was transported to City jail by officers L. G. Speers and J. D. Cober. Suspect was charged with assault to murder.

I received treatment at Parkland Hospital by Dr. Creathouse and returned to duty.

(The \$ 5.00 will be in addition to the regular \$3.88 pension dues paid semi-monthly by all members.) The amount \$ 32.50 covers the period from the date you were certified as qualified by the Civil Service Board for the position of Patrolman and therefore, the beginning of your probationary period as such, being August 4, 1953, at the rate of 3% of your base salary received during the three months' probationary period, plus 3% of your pay received during the period Nov. 4 thru Nov. 25, 1953.

Should it be your desire to take advantage of Council Action No. 441875, passed November 8, 1954, you will pay to the City Secretary on or before January 18, 1954 (60 days after becoming a member) for the Pension Fund Account \$ 94.83, or you may have this amount prorated from your next six semi-monthly pay checks by notifying my office. The time to be paid covers 3% of your salary received during the time you served your year's apprenticeship, as provided by Council Action No. 441875. Of course you understand that you will not be subject to retirement until you have served twenty years in the Department.

ACCIDENT INSURANCE

WHEREAS J. D. TIPPT

employed either as a Police or Fireman Trainee (hereinafter called "Trainees") by the City of Dallas, Texas (hereinafter called "Assured") and the Assured having agreed to pay a premium at the rate of \$3.85 per man, per month in respect of each trainee in their employ until such time as each trainee becomes eligible to join the pension plan fifteen months after his enrolment as a trainee (hereinafter called "training period") the Prudential Assurance Company Limited and the Andrew Weir Insurance Company Limited (hereinafter called the "Underwriters") agree with the Assured, his Executors, Administrators and Assigns that if at any time during his training period any trainee shall sustain any bodily injury caused by accidental violent external and visible means which shall solely and independently of any other cause occasion his death or disablement as hereinafter defined and a claim be substantiated under this policy, the Underwriters will pay to the Assured according to the Schedule of Compensation hereunder specified not exceeding in all, the sum of \$7,500.00.

SCHEDULE OF COMPENSATION

1. Death \$7,500.00.
2. Total disablement which either permanently or temporarily necessarily and continuously disables the trainee from attending to duties of any and every kind. \$40.00 per week, per man so long as the disablement continues but not exceeding altogether 260 consecutive weeks. It is expressly understood and agreed that under Item two of the Schedule of Compensation no benefits shall be payable in respect of the first 15 days following the commencement of each and every disablement.

EXCLUSIONS

- This policy does not cover death, injury or disablement -
- (a) Directly or indirectly caused or contributed to by war or invasion or while engaged or taking part in Military, Air Force or Naval service or operations.
 - (b) Directly or indirectly caused or contributed to by intentional self-injury, disease or natural causes, suicide or attempted suicide (whether felonious or not), provoked assault, duelling or fighting (except in bona-fide self-defence)
 - (c) Directly or indirectly resulting from medical or surgical treatment (except where such treatment is rendered necessary by bodily injury caused by accident within the scope of this Policy)
 - (d) Resulting from deliberate exposure of himself to exceptional danger (except in an attempt to save human life), or from his own criminal act or from bodily injury occasioned or occurring while he is in a state of insanity (temporary or otherwise) or intoxications.
 - (e) While engaged or taking part in aeronautics and/or aviation of any description or resulting from being in any aircraft or while riding or driving in any kind of race.

CONDITIONS

1. Accidental death shall not be presumed by reason of the disappearance of the trainee. Should the trainee become entitled to weekly compensation, the liability of the Underwriters shall be discharged as soon as the disablement, wound or injury shall have ceased, or been cured as far as possible, notwithstanding that some permanent or other injury may remain.
2. If the trainee shall engage in any occupation in which greater risk may be incurred than in the occupation disclosed in this policy without notice thereof having first been given in writing to the Underwriters and their permission obtained in writing (subject to the payment of such premium as the Underwriters may require as the conditions of giving such permission), then no claim shall be payable in respect of any accident arising out of or in the course of such operation.

#2 BACK

3. Immediate notice in writing must be sent to the Underwriters of any accident to the trainee and the trainee must as early as possible place himself under the care of a duly qualified Medical Practitioner. When notice is not received by the Underwriters within seven days after the occurrence of the accident, a fair and reasonable explanation for the delay must be given, otherwise the claim will not be admitted. In the event of death immediate notice must be sent to the Underwriters. In no case will the Underwriters be liable to make payment to the trainee or to his representatives unless the medical or other officer of the Underwriters appointed by them for the purpose shall be allowed to make any Medical or Surgical examination of the trainee on the occasion of any alleged injury within the meaning of this Policy, and so often as the same may be required on behalf of the Underwriters, and in the event of death to make any post-mortem examination of the body of the trainee as the Underwriters are advised is necessary for the purpose of ascertaining the extent of the alleged injuries and disablement, or the true cause of death, and no surgical examination of the body of the trainee shall be made at the instance of the representative of the trainee without due notice having been first given to the Underwriters so as to enable the Underwriters to have their medical officer present at the same time.
4. No payment shall be due in respect of any claim for weekly sums under this policy, until such claim shall have been settled and adjusted to the satisfaction of the Underwriters; any payment to made or adjusted in respect of weekly sums shall be deducted from any lump sum thereafter becoming claimable in respect of the same accident, under Item 1 of the Schedule of Compensation the balance only of such lump sum then being payable.
5. No further liability shall attach to the Underwriters in respect of any one specified trainee under this Policy after the happening of any bodily injury which results in a claim for Death or Disablement as defined in Item 1 in the Schedule of Compensation, Provided also that the total sum payable to any one specified trainee under this policy in respect of any one or more accidents occurring during the period of Insurance shall not exceed in all the largest sum insured under benefit 1 in the Schedule of Compensation.
6. It is agreed that this insurance may not be cancelled by Underwriters unless the group certificate of which this insurance is a part is cancelled. If the group certificate is so terminated the City shall not be liable for any further premium payments.
7. It is agreed that in the event of the failure of Underwriters hereon to pay any amount claimed to be due hereunder, Underwriters hereon will submit to the jurisdiction of any Court of competent jurisdiction within the United States and will comply with all requirements necessary to give such Court jurisdiction, and service of process in such suit may be made upon SURPLUS LINE ADJUSTING COMPANY and/or MENDES AND MOUNT, and that in any suit instituted against any one of them upon this contract, Underwriters will abide by the final decision of such Court or of any Appellate Court in the event of an appeal.
SURPLUS LINE ADJUSTING COMPANY and/or MENDES AND MOUNT are authorized and directed to accept service of process on behalf of Underwriters in any such suit and/or upon the request of the trainee or of his legal representative to give a written undertaking to the trainee or to his legal personal representative that they will enter a general appearance upon Underwriters behalf in the event such a suit shall be instituted.
All payments in respect of claims will be made to the Assured or his authorized representative at his address in the United States.
8. Any fraud, misstatement or concealment in relation to any matter affecting this insurance or the making by the Assured and/or trainee or by the Assureds and/or trainees legal personal representative of any claims hereunder shall be forfeited.

The following report of investigation is submitted for your information.

H. N. Bryson, Farmer, Rt. 2, Bogata, Texas:

I have known J. D. Tippit for about two years. He was renting a farm from me in 1951 and 1952. In 1951 he raised a fair crop but in 1952 it was very dry and we didn't get to plant until June. J. D. left here about June 1, 1952 before planting time. He is an honest boy, pays his bills, and takes care of his family. J. D. is a fairly good worker and takes care of his equipment. The Tippets had no family trouble while they lived here. The boy has a temper but he knows how to control it. J. D. is a likeable boy but never has a great deal to say to anyone.

Margaret Mangel, Personnel Manager, Sears Roebuck & Company:

J. D. Tippit was employed here on two occasions as an insulation installer. The dates of employment were: March 23, 1948 to May 2, 1948, (He resigned to take other employment), May 17, 1948 to September 6, 1949 (He was laid off due to reduction of the force.) Tippit's work was satisfactory and there were no complaints on his work.

Connie Smith, Secretary, Dearborn Stove Company:

J. D. Tippit was employed by Dearborn as a shipping helper from November 9, 1946 to March 19, 1948. Tippit was a good worker, prompt, and reliable. He was laid off in a slack period and did not return.

Alfred Robinson, Farmer, Rt. 2, Bogata, Texas:

J. D. Tippit has been a neighbor of mine for many years. The Tippets are a nice family, respectable and upright. J. D. is an honest, hardworking, and sober boy. He has never had any trouble of any kind. J. D. is a quiet fellow and has very little to say. I don't believe he is shy or bashful, as he will speak up to anyone if he believes he is right.

W. L. Gasway, Farmer, Rt. 2, Bogata, Texas:

J. D. is a good worker, honest, dependable, and capable. I have known the boy for ten years and have found him a very likeable boy. J. D. has a good service record in the army. He was a paratrooper in the 82nd Airborne Division

and made numerous jumps in Europe. J. D. is a little nervous still and is startled by any loud unusual noise. J. D. and Marie have been married for four years and they get along very well together. They have the usual family arguments but nothing serious. J. D. has a good sense of humor and likes to be friendly with people. He has a bit of temper but never lets it get out of hand. I have seen J. D. drink some but it was before he was married. He doesn't drink at all now.

Paul Hill, Gin Operator, Fulbright, Texas:

I have known J. D. Tippit for about 20 years. He is from a fine family and is hardworking boy. J. D. is honest, pays his obligations, is even tempered, and was never in trouble here. He is a likeable boy and he tends strictly to business. J. D. is a quiet boy and says very little.

E. W. Verner, Minister, Commerce, Texas:

J. D. was a member of my congregation for several years and I believe he is a fine boy. I would say he has average intelligence, is capable of meeting the public, and is a level headed fellow. He is likeable, has a clean cut appearance, and has little temper.

M. H. Brunley, Patrolman, Dallas Police Department:

I have known J. D. Tippit for many years and I went to grade school and high school with him. J. D. was a very shy and bashful boy when he was going to school. He had several fights in school with people who mistook his shyness for fear. After J. D. won a few of these fights he had no further trouble. He had a good record in the paratroops during the war and he got over being shy in the service.

J. D. Tippit has no police record in any of the towns in which he has lived. The Retail Merchants Association of Dallas and Clarksville report that J. D. Tippit has a very satisfactory credit rating with one exception. Tippit has owed an account at the Walker Appliance Store of Clarksville, Texas, since September 11, 1949. The amount past due since that date is \$17.50.

Tippit completed the eighth grade of school at Fulbright, Texas. He attended two years at the Veterans School of Clarksville, taking auto mechanics and general shop training.

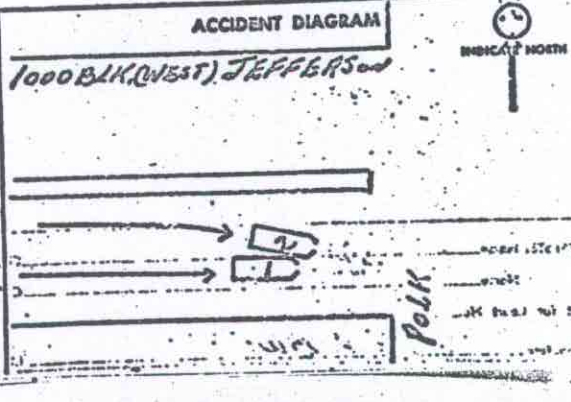

Case:

Mrs. Stegall called the Personnel Office about 3:30 p.m., May 6, 1961 and stated Officer Tippit gave her a ticket for Running a Blinking Light and No Operator's License shortly before then. She said she drove up the street a short distance and found her license and returned and found the officer talking to another person. She said she stopped across the street from the officer and held up her license and told the officer she had found her license. She stated Officer Tippit told her he was busy then and would talk to her in a minute, but got in his car and drove away when he finished talking with the other person leaving her sitting there. She felt he was being discourteous by not coming and talking to her.

Statement of Officer J. D. Tippit:

I gave Mrs. Stegall a ticket for Running a Red Blinking Light on Edgefield at Beckley Friday afternoon, May 6, 1961. She said she had changed purses and could not find her drivers license, so I also gave her a ticket for No Operator's License. About 30 minutes later, I was stopped writing another ticket a little further North on Edgefield and Mrs. Stegall stopped on the other side of the street and told me she had found her license. I excused myself from the man I was with and told Mrs. Stegall to bring them with her to the court with the ticket. When I finished writing the man I had stopped at that time, I drove away. I did not realize Mrs. Stegall was still there. I thought she had found out what she wanted to know. If she was still there and was expecting me to talk further with her, I am sorry. I certainly would not have been that discourteous had I known she understood things that way.

Note: The tickets issued to Mrs. Stegall were set in Court #3 at 9:00 a.m., May 19, 1961. They were issued at 2:20 p.m., May 6, 1961, and the ticket Officer Tippit was writing at the time Mrs. Stegall returned and showed him her license was dated at 2:15 p.m. Mrs. Stegall possibly might have had time to have gone home and returned with her license. She must have gone longer than she inferred when she reported the incident.

Mrs. Stegall entered the hospital May 9, 1961. Her daughter was contacted May 10, 1961 and she is going to bring the tickets to the Fines Bureau with Mrs. Stegall's license and take care of the tickets for her. Mrs. Stegall will be contacted later and given an explanation of why the officer did not talk to her further. It is possible she did understand but used that as an excuse to complain about the tickets.

Sir:

Officer J. D. Tippit has been with the department since July 28, 1952. He has worked in the Radio Patrol Division since his graduation from police recruit school.

Patrolman Tippit has a broad knowledge of police work and it is his desire to perform his duty in a manner to bring credit to the department and himself. His knowledge of police work and his steady influence on younger partners has been used to a good advantage in breaking in newer officers.

Officer Tippit is well liked by his associates and gets along good with all the men who have worked with him. All the officers who know Officer Tippit have a high regard for him and respect his judgement.

Officer Tippit is a devoted family man and very fond of his two children. He spends most of his off duty time with his family and they usually plan their activities and trips where they can attend together. Officer Tippit attends church with his family when his off duty hours permit.

The initiative of Officer Tippit is best expressed by his work record and his desire to do extra police work to help better himself in his neighborhood surroundings. The desire of this man to better himself in his chosen profession and to be a well liked and respected family man is evident to his associates.

Officer Tippit is keen in his observation of all unusual incidents on his district and he makes every effort to become as familiar with his district as possible.

Officer Tippit was not able to work the last two months of 1956 because of an injury sustained while on duty. He made 911 total arrests during the ten months he was able to work. He made 348 jail arrests, issued 524 moving traffic violations and issued 38 parking tickets. This excellent work record was accomplished on district 104, which is primarily a residential section of town.

Officer Tippit was outstanding with his judgement and quick thinking during 1956.

On April 28, 1956 at approximately 8:30 P. M. Officer Tippit and his partner received a radio call to meet complainant regarding a demented person. Upon

their arrival, Tippit was told by complainant that her husband was inside the house armed with an ice pick and had run her out of the house, threatening to kill her and himself.

The complainant stated she thought her husband was crazy and wished the officers to disarm him and see that he got medical attention. This request brought an immediate response from Officer Tippit and his partner and, as they entered the house, the demented person stabbed both officers with an ice pick. Officer Tippit was stabbed in the stomach and the knee. The demented person was subdued by force and was not injured at all. Officer Tippit and his partner faced a great danger in an outstanding performance of police duty. Their only thought was to subdue the demented person without injuring him.

On September 2, 1956 at approximately 12:30 A. M. Officer Tippit and his partner checked out for routine investigation at 441 West Commerce. They observed a white male inside this place, who appeared to be intoxicated and asked him to accompany them outside. This person was sitting at a booth and as he got up, he drew a gun from his belt and told the officers to "stick 'em up." He had the gun pointed at Officer Tippit's face and as Tippit and his partner backed up a little the suspect pulled the trigger in an attempt to shoot Officer Tippit. The gun was an automatic and evidently one of the safety locks was still in position because the gun didn't fire. Officer Tippit and his partner drew their service revolvers and fired at the man until he fell. Officer Tippit advised his partner to call for an ambulance and tell the dispatcher what had happened. Officer Tippit immediately locked the business to hold the witnesses.

This person was dead on arrival at the hospital and was later identified as Leonard Garland, who was wanted by the Federal Bureau of Investigation for an offense he committed in another state.

Officer Tippit did not have an accident in 1956. Tippit is a careful and courteous driver and sets a good example with his driving.

Officer Tippit has not had disciplinary action taken against him since entering the Department.

The excellent judgment and quick thinking of Officer Tippit has been consistent throughout the year of 1956. The action and performance of duty by Officer Tippit during 1956 deserves recognition.

in the face. A restraining hold subdued Arrendondo. During the struggle
to subdue Arrendondo, he received a broken upper right tooth. He had re-
cently had dental work done on this tooth.

Mr. Arrendondo was treated at Parkland Hospital and then placed in jail
charged with being Drunk and Disorderly Aggravated.
