a background investigation was conducted on SUBJECT and the
following is submitted.

SUBJECT has been known to T-1 since 1959 at which time SUBJECT was living at 3116 ALASKA. At that time SUBJECT was married to JIMET IDEARD MC DONALD but was divorced from him in December 1961 here in DALLAS. This divorce is recorded at DALLAS COURTY DISTRICT CLERK'S OFFICE, cause # 61-7095.

T-1 further stated that SUBJECT has one (1) daughter.

CYNTHIA ANN MC DONALD w-f 4. SUBJECT lists her next of kin
as MRS. ROY WITHERSPOON of 939 PLEASANT RUN ROAD, LANCASTER.

TEXAS. T-1 does not know the relationship between this person
and SUBJECT.

Source also stated that SUBJECT is now living at 4214 W. TENTH ST., DALLAS, TEXAS and has formerly lived at 427 W. TENTH, 3281 E. MINTH and 2921 MICHIGAN. T-1 lists SUBJECT as being a dancer at the THEATRE LOUNCE however BARNEY WEINSTEIN states that SUBJECT has never been employed at THEATRE LOUNCE in any capacity. Her place of employment is unknown.

The indices of the Identification Eurean of this Department failed to reveal a criminal record on SUBJECT. The search of indices was made by Clerk CROSSLAND.

The indices of the Identification Bureau of the SALLAS COUNTY SHURLEF'S OFFICE failed to reveal a criminal record on SUBJECT. The search of indices was made by Deputy SANDERS.

All indices of the Special Service Bureau failed to reveal any information other than the above listed arrest on SUBJECT.

The indices of the Identification Bureau of the FORT WORTH POLICE DEPARTMENT failed to reveal an arrest record on SUBJECT.

Information had been received that SUBJECT was a FORT WCRTH resident however there is no evidence to substantiate this information. The address, 424 W. TENTH, FORT WCRTH, TEXAS is a non-existant address. All of the 400 Mock W. TENTH in that city is occupied by a large parking lot in the block west of the FORT WORTH CITY HALL.

None of the various credit agencies in FORT WORTH had any present seconds nor had there been any inquiries from any business firms in that city regarding SUBJECT.

Pursuant to the instructions of Captain W. P. GANNAWAY, SUBJECT was interviewed by the undersigned officers and the following report submitted.

SUBJECT, who was born in Poland, resides at 5930 La Vista Drive with his wife, ANNA, who is Russian born. Their telephone number is TA3-2219. He is employed as a packer at SANGER-HARRIS DEPARTMENT STORE and she, as a draftsman at the DALLAS POWER & LIGHT COMPANY.

MRS. MELLER stated that she and GEORGE BOUHE wont to a small party at the residence of PETER GREGORI in Fort Worth during the summer of 1962, where they met LEE HARVEY and MARINA OSWALD. She and BOUHE visited the OSWALDS at 2703 Mercedes in Fort Worth two or three times after that to take them food and clothing. OSWALD become very belligerent on these occasions, saying that he didn't need or want help from envone. MRS. MELLER also said that she saw the book, "CAPITAL", which was written by KARL MARK, during one of these virits at OSWALD'S house and became very worried about it. SUBJECT said he checked with the FBI and they told him that OSWALD was all right.

SUBJECT stated that a friend of his, MRS. CUNNINGIAM with the TEXAS EMPLOYENT COMMISSION, helped OSWALD get a job with a photo engraving company in Dallas in October of 1962. When SUBJECT told oswald that he should thank her for getting him the job, he said, "Why should I thank anyone for getting me a job where I only make \$1.25 an hour."

On or about Hovember 5, 1962, MARINA telephoned MRS. HELLER and told her that LKS HARVEY had beat her up and she had left him. MRS.

MELLER invited her to stay at her home for a few days. On November 11, 1962, MARINA left the MELLERS and want to stay at the residence of DECLAH FORD.

SUBJECT stated that the last time he and his wife saw the OSWALDS was at a party on December 28, 1962, at the DECLAN FORD residence.

GEORGS ds MCHRENSCHILDT had brought the OSWALDS to the party.

MR. and MRS. HELLER both felt that LEE HARVEY OSWALD had a serious psychological problem. They did not know JACK RUBY.
