Interview: Mr. STRINGFELLOW was interviewed by Investigators BROWN and DALY in Dallas, Texas. Mr. STRINGFELLOW was a former Dallas Police Department Detective. assigned to the Intelligence Division. According to a F.B.I. report (which is the only official report of HALL's arrest) Mr. Stringfellow notified the F.B.I. that a person who was under arrest desired to talk to them. It further amplifies that he verified a local T.V. station giving film to HALL for usage inside Cuba.

Mr. STRINGFELLOW was shown copies of the arrest reports concerning HALL & SEYMOUR but he only vaguely recalled any such incident. He was unable to recall any further details concerning the potification of Intelligence Agencies of behald of the subjects. He amplified upon the basic procedures which were in usage in October, '63 and gave the investigators some names of the personnel who would have been involved in said arrest procedures, plus those who were involved in the investigation of OSWALD. He refers to the two cooperative F.B.I. men assigned to the Dallas office, Ike LEE and Bob BARRETT, as those who they had the most dealings with.

He FEELS now, as he did at the time, that the shooting of the President was due mainly to a CUBAN connection with an undercurrent of Communistic leanings. He feels that OSWALD, at the time he shot TIPPITT, was attempting to contact someone to assist him in getting to CUBA, he doesn't have any name who help OSWALD might have been seeking. He feels strongly that MARINA OSWALD knew all about it. The day that RUBY shot OSWALD, STRINGFELLOW was called at home and told to come

to the office and get out the file (Intelligence) on RUBY. He did and turned it over to some 'Chief' and has not seen it since. It (the file) showed RUBY as a homosexual a dance hall operator and a general character. He was a noted name-dropper who would like to have been a 'big-shot'. Was unaware of any particular Organized Crime family to which he might have belonged. Further states that he was a pimp who would buy 'ho merchandise. (DALLAS P.D. apparently conducted an extensive investigation into a possible OSWALD-RUBY connection.) He can give no specific reason, but he firmly believes that the shooting of the President stems from a conspiracy of some sort. He states that he will never be convinced otherwise, although he DOES NOT possess any concrete information for this belief.
