# MOTION TO DETERMINE CUSTODY OF PETITIONER PENDING APPELLATE REVIEW

Comes now the Petitioner, Christian David, by counsel and moves the Court pursuant to Rule 23(a) of the Rules of Appellate Procedure for the United States Courts of Appeals as follows:

- Petitioner has herewith filed his Notice of Appeal with respect to the decision of the Court denying his Consolidated Petition for Habeas Corpus Relief.
- 2. Rule 23(a) of the Rules of Appellate Procedure for the United States Courts of Appeal provides as follows in part:

Pending review of a decision in a habeas corpus proceeding commenced before a court, justice or judge of the United States for the release of a prisoner, a person having custody of the prisoner shall not transfer custody to another unless such transfer is directed in accordance with the provisions of this rule.

3. Petitioner is entitled to an appellate review of the decision of this court as provided in 28 U.S.C. §2253 as follows:

In a habeas corpus proceeding before a circuit or district judge, the final order shall be subject to review, on appeal, by the Court of Appeals for the circuit where the proceeding is had.

4. Petitioner is concerned that he obtain a full and fair hearing of his claims and based on his prior experiences he is apprehensive about what treatment he will receive.

WHEREFORE, Petitioner moves the Court to enter an order instructing the United States Marshall, the Department of Justice and the Department of State to not transfer the custody of the Petitioner to any other person or party pending the further order of this Court.
