1. OLD HANDS AT STATION CONFIRM JMMOVE WAS THE ONLY AGENCY SPONSORED TRAINING CAMP. TO THE BEST OF STATION KNOWLEDGE THERE WAS NO STATION NOR AGENCY SUPPORT OR FUNDING OF THE MDC TRAINING CAMP. THE ONLY INFORMATION WE CAN DIG UP WHICH MAY RELATE TO MDC CAMP IS AMOT REPORT DD 293, DATED 25 JULY 63, WHICH STATES THAT THE CAMP WAS LOCATED ABOUT 15 MILES FROM NEW ORLEANS, RIGHT AFTER CROSSING VERY LONG BRIDGE RIGHT AT ENTRANCE OF STATE OF LOUISIANA. SOURCE OF REPORT DID NOT KNOW NAME OF RANCH WHICH BELONGED TO SOME AMERICAN MILLIONAIRES WHO WERE DEFRAYING EXPENSES FOR MAINTENANCE OF MEN IN TRAINING AND PROVIDING EQUIPMENT. APPROX 30 MEN WERE IN TRAINING THERE. SOURCE ALSO STATED THAT ON 24 JULY 63 TWO AUTOMOBILES LEFT FOR LOUISIANA WITH COMMANDANTE DIEGO. (NOTE DIEGO IS AKA OF VICTOR MANUEL (PANEQUE) BATISTA, SEE SUBPARA G BELOW.)

ANDERSON COLLINS, AKA EDMUND ANDERSON COLLINS, AKA EDWARD COLLINS. THIS COLLINS IS, OR WAS, A MEMBER OF INTERPEN AND HAS BEEN MENTIONED IN DBA 7579 OF 30 AUGUST 62 AND 286684 DATED 6 DECEMBER 62. STATION TRACES REFLECT THIS COLLINS WAS A COLLEAGUE OF LAWRENCE LA BORDE. THIS COLLINS HAS ALSO BEEN REPORTED ASSOCIATING WITH ROBERT KENNETH BROWN, PANTHER PUBLICATIONS (JMWAVE 9245, SEPTEMBER 67).

B. HOWARD KENNETH DAVIS - LOCAL CARD SHOWS JMWAVE WAS QUERIED RE POSSIBLE USE OF SUBJECT PER DIR 38007, MAY 63. JMWAVE 8213, MAY 63, SAID NO INTEREST. STATION SECURITY FILES SHOW HE IS MARRIED TO NERTA, AND LIVES AT 10832 SW 61 TERRACE, MIAMI, FLORIDA. DAVIS HAS A WIDE CIRCLE OF ACQUAINTANCES IN MIAMI AREA, AMONG ANTI-CASTRO CUBAN, AND ANTI-DUVALIER HAITIAN GROUPS. DURING MIDDLE AND LATE 1950'S DAVIS ALLEGEDLY WAS AT LEAST AN ACQUAINTANCE, IF NOT A COLLEAGUE, OF WILLIAM MORGAN,

ASSASSINATED BY CASTRO IN CUBA. IT IS KNOWN THAT DAVIS HAS KNOWN ROBERT K. BROWN FOR SOME TIME, AS ATTESTED TO BY THE FACT THAT A LOCAL NEWSPAPERMAN WAS INTRODUCED TO BROWN BY DAVIS. (SEE JMWAVE 9172, SEPTEMBER 67)

IN 1963 DAVIS LIVED AT 3350 NW 18 TERRACE, MIAMI, AND CLAIMED TO BE SELF-EMPLOYED IN THE AIRCRAFT INDUSTRY. HE PRESENTLY OWNS THE PROPERTY AT ADDRESS SHOWN ABOVE AND IS CURRENTLY EMPLOYED AS A PILOT BY AIRLIFT INTERNATIONAL, MAKING IN EXCESS OF \$700 PER MONTH. HIS WIFE, MERTA, WHO IS OF CUBAN EXTRACTION AND TO WHOM HE HAS BEEN MARRIED FOR AT LEAST TEN YEARS, IS A LABORATORY TECHNICIAN. AS OF 1963, SHE HAD BEEN EMPLOYED BY THE UNIVERSITY OF MIAMI, MAKING APPROXIMATELY \$300 PER MONTH. DAVIS WAS BORN 11 AUGUST 30 IN CHICAGO, ILLINOIS, AND CAME TO FLORIDA FROM NORTH CAROLINA IN 1952. HE IS DESCRIBED AS A WHITE MALE, FIVE FEET SIX INCHES TALL, WEIGHING 156 POUNDS, WITH BROWN HAIR AND BROWN EYES. HE HAS NO LOCAL POLICE RECORD: THERE ARE STATION TRACES ON DAVIS. ONE OF THE CARS WHICH PLAYED AN IMPORTANT PART IN THE BROWN CASE, AND WHICH DELIVERED PACKAGES TO BROWN, IS REGISTERED TO AN INDIVIDUAL NAMED GIL
