SITE AT NEW ORLEANS UTILIZED BY DAVIS TO TRAIN EXILED CUBANS. PURPOSE OF TRAINING WAS TO KEEP EXILED CUBANS BUSY WHILE IN UNITED STATES AND NOT FOR INVASION PURPOSES. TRAINING SITE LOCATED ON DE LA BARRE ESTATE NEAR LACOME, LOUISIANA. DE LA BARRE ESTATE CLOSELY ASSOCIATED WITH JOHN BIRCH SOCIETY ACCORDING TO DAVIS.

DAVIS STATED TIME-LIFE CORP. PREPARING DETAILED STORY RE GARRISON PROBE AND INCORPORATING PHOTOS OF DAVIS'S TRAINING CAMP IN ARTICLE. HOUSTON INDICES NEGATIVE ON DAVIS. DAVIS ADVISED HE HAD BEEN INTERVIEWED IN PAST BY FBI, NEW ORLEANS.

NEW ORLEANS IMMEDIATELY REVIEW INDICES AND ASCERTAIN THAT ALL PERTINENT INFORMATION FURNISHED BUREAU. *Letterhead Memo* LHM FOLLOWS.
