On 12/20/76, Ms. HELEN TOWNE, Secretary to W.O. BANKSTON, 4747 LBJ Freeway, Dallas, Texas, telephone 233-1441, at the direction of W.O. BANKSTON, met with SA ROBERT P. GEMBERLING at the Office of Mr. TOM E. TUNNER. Senior Vice President, National Bank of Commerce, Dallas, Texas. Vice President, National Bank of Commerce, Dallas, Texas. She had in her possession a folder of documents which she stated had been given to W.O. BANKSTON by Sheriff J.E. This folder was found to contain copies of letters to various persons from Sheriff DECKER acknowledging receipt of donations of money to the widow of Dallas Police Officer of donations of money to the widow of Dallas Police Officer allegedly J.D. TIPRIT. who was the Dallas Police Officer allegedly shot by OSWALD on 11/22/63. The remainder of the documents in this folder are identical to Warren Commission Exhibit in this folder are identical to Warren Commission by Sheriff No. 5323, made available to the Warren Commission by Sheriff J.E. BILL DECKER when he appeared before the Warren Commission to testify as reflected in Volume 12, pages 42-62 of the Warren Commission report. In the presence of Ms. TOWNE, warren Commission report. In the presence of Ms. TOWNE, each page in the folder was compared to identical pages contained in the Dallas copy of "Decker Exhibit 5323."

There was one page in the folder made available by Miss TOWNE which was not located in the Dallas copy of "Decker Exhibit No. 5323." This page is a supplementary & 13-4943 investigation report by C.C. GENTRY of the Dallas County investigation report by C.C. BENNY JAMES. Route 6, Box 122A, Dallas, Texas, had called (no indication of whom he called) and stated O.B.
