## Commissioner Due To Open

Police Commissioner Donald D. Pomerleau is expected to be the first witness at a State Senate hearing called today to determine whether an independent investigation of the police department's Inspectional Services Divsion is necessary.

The ISD has been accused of spying and keeping dossiers on newsmen, elected officials and

clergymen.

Mr. Pomerleau has denied any wrongdoing by the ISD but the Senate's Constitutional and Public Law Committee will seek to determine through questioning whether in fact there are grounds for a fullscale look into the secret division's activities.

## List Could Swell

The committee plans to call about 12 witnesses but, according to Senator Edward T. Conroy (D., Prince Georges, 24th), chairman of the new constitutional committee, the list of witnesses could swell.

"Anyone that can bring information of a credible nature to this committee will be welcome to testify. We are not going to limit ourselves to a prepared list," he said.

Mr. Conroy said that sena-

tors who wanted to participate in the hearing but who were not members of the committee would be allowed to offer ques-

tions to the interrogating panel. Senator Verda F. Welcome (D., city 40th), the author of a resolution issued last week which called for an independent investigation of ISD, was to open the three-hour hearing with an introductory statement concerning the unit's activities. intelligence

There were reports that Mr. 1- Carrier complained that Leon-- ard Jenoff, a man working for y Liddy Jones's attorneys, was an informant for ISD. Mr. Carrier never produced evidence f to substantiate the charge.

Mr. Conroy said that he and y the committee were prepared to conduct a thorough investigation despite criticism that the body had done little to orientate itself to the full scope of the charges.

"I am not from Baltimore but I read The Sun," Mr. Conroy said. "I also read the editorials.

"Senator (Cornell N.) Dypski (D., city 47th) is on the committee and the senators from Baltimore county are close to the situation.

"Most of the committee will be prepared; they'll know that questions to ask," he
